

## **Anderson Ranch Neighborhood Meeting Summary**

The Anderson Ranch neighborhood meeting was presented at the Otho E Stuart Middle School on March 15, 2023, from 5:00 PM - 6:30 PM. The letters regarding the meeting were sent out on March 2, 2023, a total of 324 letters were sent out, a letter was sent to any landowner that is located within a 500' radius from the property. There was a total of 8 people that had showed up to the meeting some of the concerns were,

- 1) Traffic issues/Drunk drivers.
  - a) Traffic concerns have been identified in the traffic study and will be mitigated through the annexation agreement and impact fees.
  
- 2) Blocking views from chambers road.
  - a) All housing types shall not exceed 35 feet in height which reflects the city's housing height restrictions.
  
- 3) How tall the houses are going to be.
  - a) No taller than 35 feet.
  
- 4) Not enough stores in the area.
  - a) The rooftops generated by Anderson Ranch will help entice more companies/stores to want to have a presence in Commerce City.
  
- 5) The width of chambers road in the future.
  - a) Referred concern to Commerce city's engineering department.

- 6) Prefer single family over multi-family homes.
  - a) Most of the housing is single family detached with some attached townhome housing to allow for a mixture of housing types and price points. The project will not have any apartments or stacked housing.
  
- 7) Deteriorating Conditions of the roads when the development starts construction.
  - a) Referred concern to the city's permitting/public works department.
  
- 8) Timeframe when we start building.
  - a) Approximately 2 years.
  
- 9) One neighbor commented they've heard gunshots near the property.
  - a) No comment
  
- 10) Neighbors states they don't like Oakwood Builder.
  - a) No Comment

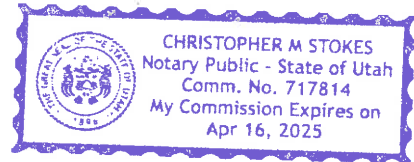

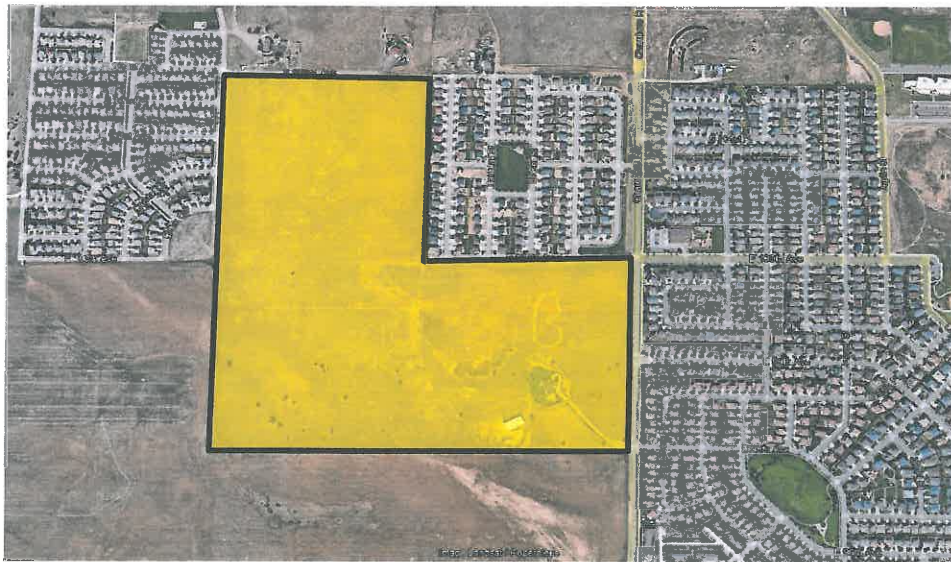
