



Proposed Use Description

Stout Street Foundation (SSF) is requesting an ongoing renewal for our conditional use permit for the property located at 7201 and 7251 E. 49th Ave Commerce City, CO 80022. The property will continue to be used for inpatient adult substance abuse treatment and serve as Stout Street Foundations headquarters. SSF is a 501 (c) 3 nonprofit organization incorporated in 1976 our motto is “Helping People Help Themselves”.

Since 2003 SSF has been very proud to call Commerce City our home.

-7251 E. 49th Ave is our Administration Building consisting of offices for our clinical and operational staff members.

-7201 E. 49th Ave is the former Economy Inn Hotel that our residents live at while in the First Phase of our Program (approximately 18 months) before transitioning to After Care and our Sober Living Home in Denver (approximately 6 months).

The need for the services that Stout Street Foundation offers the community have always been enormous however with the current state of the opioid crisis and unprecedented homelessness challenges facing our community, SSF’s mission is more critical than ever. We will continue to use our resources to improve our campus so that we are able to be here now and into the future as a beacon of hope for so many struggling with substance abuse disorders.

Statement of Operations

Stout Street Foundation operates as a drug and alcohol rehabilitation center. 24 hours a day and 7 days a week we have a staff presence on site. We currently have 20 full-time staff members and 5 part-time staff members. The property has 174 total off-street parking spaces available. Typically, in any given week we have an average of 2-3 deliveries to our facility, mainly food items.

Stout Street Foundation reports to the following regulatory agencies:

-The Colorado Behavioral Health Administration (BHA)- Annual inspections and audits of our programs are completed.

- Adams County Health Department- Annual kitchen inspections as well as guidance and resources during the Covid 19 pandemic.

- South Adams County Fire Department- Annual inspections of both facilities and training is conducted on site as well by SACFD.



Stout Street Foundation has been operating in the same location in Commerce City since 2003 and we are very thankful to be part of such an amazing community. The safety of our staff, residents and community are always our priority. Stout Street Foundation serves clients that are both voluntary or “walk-in” as well as residents referred to our program from the judicial system as an alternative to incarceration. Prior to admission to our program, SSF conducts interviews and runs background checks on all prospective residents that are applying to be part of our Recovery Community to ensure that we do our due diligence to filter out any individuals with a history of violence, sexual crimes and arson from entering our program.

In our 20 plus years of being in Commerce City we have prided ourselves on partnering with several local businesses in and around the industrial park area to provide additional vocational training options for our residents (letters attached). SSF looks for volunteer opportunities within our community such as with the Sand Creek Regional Greenway to clean up trash along Sand Creek. SSF partnered with the Commerce City Police Department and Homeless Outreach Navigator to help be a resource for unhoused individuals in our community struggling with substance abuse. SSF is very excited to announce that we were selected by the Adams County Opioid Response Council for funding this year to help support our ongoing efforts on the front line to combat opioid abuse in our community.

Stout Street Foundation will continue to operate in the same capacity that we have had for over 20 years in our current facility. This means there will be no additional impact on our surrounding neighbors. Stout Street Foundation is a proud member of the Commerce City community and looks forward to being here for years to come as home for so many struggling individuals that are looking for an opportunity to find a better chance at a more meaningful life.


Members of the Adams County Opioid Abatement Council,
