During 2023, an RFP was completed, three grant writing firms were selected, and the City entered into contracts with FHU, Lotus Engineering & Sustainability, and Eleventh House Solutions for grant writing services and solutions. These contracts are being used in beginning in 2024.
2	Rental Assistance Program (Ordinance No. 2533)	Various	\$ 500,000.00	\$ 500,000.00	\$ -	\$750,000 was budgeted for Rental Assistance in 2023. \$250,000 of this was general funds and \$500,000 was ARPA funds. A total of \$784,493 was spent on Rental Assistance in 2023. Although this line item went over budget by \$34,493, this was easily absorbed by budget savings in other line items within the Community Development Department.

These systems provide capabilities to rescue stranded motorists and individuals during heavy snowstorms and inclement weather. The original estimated cost was \$75,000 and the actual cost was \$72,000. The \$3,000 remaining allocation will be transferred back to the General Fund from the Fleet Fund as part of the ARPA budget carryover ordinance being presented to Council on 3/18/24 for future reallocation by Council.
