#### 58th Annual Memorial Day Parade: Grand Marshal nominations now open

The city is looking for nominations of military veterans in our community to serve as grand marshal for Colorado's largest Memorial Day Parade on Monday, May 27. Nominees can include veterans young and old from any branch of the armed forces, as well as local Gold Star Families to attend in honor of service members who have fallen in combat. The grand marshal will be recognized before the parade during a ceremony at Veterans Memorial Park before leading the parade to be acknowledged by the crowd.

#### Nominees must be:

- A veteran (proof of discharge required) or active-duty member of the military or a Gold Star Family with an immediate family member who has fallen while serving in a time of conflict
- A current or former resident of Commerce City
- Willing and physically able to act as grand marshal, attend the Memorial Day Ceremony, and ride in the parade

## Business/Economic Development



- Staff met with the owner of a fitness concept to discuss their conceptual plans for a new location in Commerce City. They confirmed the initial phase of development would be 13,000 square feet and feature an outdoor training area. Staff is assisting the engineering team to source clean fill dirt for a detention pond as a follow up to the meeting.
- Staff conducted a real estate search for a screen printer looking for an industrial space for lease. The tenant is targeting a space ranging from 10,000 35,000 square feet.
- Staff met with the owners of a proposed brewpub restaurant. They provided an update on conceptual design plans. Staff updated the owners on the results of an environmental survey work done as part of their due diligence for their financing.
- Staff attended a Rotary Club of Commerce City meeting to extend an invitation to the upcoming Economic Development Strategic Plan outreach meetings in March.
- Staff attended the Colorado NAIOP (Commercial Real Estate Development Association) Annual Awards of Achievement.
- Staff received an update on the construction and opening date for tenant that will take over former drive thru restaurant on E. 104th Ave. They confirmed an anticipated date of their soft opening will be in mid Q2.

— Staff met with CLIMBER Loan Fund administrator Apex Consulting. Apex is located in Commerce City and will be included in the business resource index created for the business retention and expansion website.

#### CCPD Prepares to Unveil "High Traffic Hazard Zones"

In two weeks, Commerce City will be home to four brand new "High Traffic Hazard Zones." If you are committing a traffic violation in those zones-- most notably speeding egregiously-- the fine that accompanies your citation will be doubled.

We crunched citation numbers to determine which roadways in our city have the most dangerous problems in regards to risky driving behavior and determined both Tower Road and Highway 2 would benefit most from these new zones.

Rest assured we are not trying to make your life miserable; we're trying to save your life and prevent what's preventable — crashes caused by reckless driving. We've had numerous fatal collisions on these two roadways. If that's not a deterrent then maybe a hefty fine will be.

The "High Traffic Hazard Zones" don't include all of Tower and Highway 2, but rather two sections on each:

- 1. Highway 2 between E. 72nd and E. 79th
- 2. Tower Road between E. 81st and E. 87th
- 3. Highway 2 between E. 88th and E. 95th
- 4. Tower Road between E. 96th and E. 103rd

You'll see VMS boards in these locations now and permanent signage soon. Consider yourselves amply warned: "High Traffic Hazard Zones" go into effect on Monday, March 18.

#### CCPD Responds to Serious Injury Crash Involving 14-Year-Old Driver

There's a reason we want you to abide by law, and it's not just because we may ticket you.

On Tuesday morning a sedan with four juvenile males in it was traveling at what we believe was likely a high rate of speed on E. 88th Avenue. The vehicle struck a guardrail, then veered into oncoming traffic, hitting a minivan carrying two adult women nearly head-on.

Both women sustained serious bodily injury but will be okay. All four of the kids in the at-fault vehicle were ejected. The driver was only 14 years old; the front passenger was just 12.



The driver's injuries are critical. All six people involved in this preventable crash were transported to area hospitals. Our traffic team continues to plead with drivers and passengers — slow down, wear your seatbelt, and never get behind the wheel without a license.



### Infrastructure

#### **PW Updates**

#### **Preservation and Safety**

- The City's Asphalt Crack Repair Project continues to move forward. This past week, 8 repairs in the Reunion neighborhood were completed, bringing the total number of cracks repaired under the project to 62.
- Snow Operations staff responded to the Snow Squall that passed through on Tuesday, February 27th dropping 1.5 inches of snow in a matter of minutes. A total of 671 miles of roadways were plowed and treated with de-icing material.

#### **Engineering**

- Staff submitted an application for the Rebuilding America's Infrastructure with Sustainability and Equity Grant (RAISE) for \$20,000,000 to reconstruct E. 88th Avenue.
- Work is progressing on the Electric Vehicle (EV) Charging Stations at the Municipal Services Center, the Eagle Pointe Recreation Center, and the Civic Center.
- The City's Municipal Separate Storm Sewer System (MS4)
   Annual Report was submitted to the Colorado Department of Public Health and Environment (CDPHE).
- A coordination meeting was held with the Colorado Department of Transportation (CDOT) to discuss the remaining interim bridge repairs along I-270. These repairs will extend the life of the bridges until they can be reconstructed with the I-270 Reconstruction Project. Work is planned to start the evening of Sunday, March 17th and last for two weeks.
- Staff held a construction coordination meeting with the contractor for the Automated Traffic Signal Performance Measures (ATSPM) improvements. Once completed, this project will provide real-time and historical functionality at signalized intersections along arterial roadways and will send alerts to the Traffic Operations Center (TOC) related to the operation of the traffic signal. This will allow the City's Traffic Engineers to identify opportunities to improve signal timing. The project is underway and approximately 20% complete.
- Staff held a design review meeting with CDOT staff for the Signal Head and Backplates Improvement Project.
- A weekly meeting was conducted for the E. 120th Avenue Widening Project between Chambers Road and Buckley Road.

- Teams completed the delineation of E. 96th Avenue from the Second Creek Bridge to Landmark Drive.
- Staff repaired/replaced downed signs on E.104th Avenue and Chambers Road and at E. 96th Avenue and Tower Road.
- Staff repaired potholes in the Eagle Creek neighborhood and Derby area.
- Water was pumped from the drainage detention pond at E. 64th Avenue and Holly Street.

#### **Another Successful Greyhound Park Milestone in the Books**

Another exciting milestone has been accomplished at Mile High Greyhound Park! Delwest, a Denver-based residential real estate development firm, has constructed and delivered the first building of rowhomes to new residents. This phase of construction contains 68-units of built-to-rent townhomes that each boast 4 bedrooms, 2.5 bathrooms, and a 2-car garage. The rowhomes were financed with a construction loan through the Colorado Housing and Finance Authority's Middle Income Access Program. The program addresses the middle-income workforce, sometimes referred to as the "missing middle," with incomes too high for Housing Credit units but often overburdened by market rents. The loan requires 25% of the units to be subsidized for households



earning at or below 80% Area Median Income, furthering the vibrancy of this master-planned mixed-income neighborhood.
