### Installation underway on new EV charging stations at city facilities

Work began this week to install new charging stations for electric vehicles at the Commerce City Civic Center, with subsequent installations to follow at other facilities. Available for both public and employee use, the city is installing one station at the Municipal Services Center, two at the Eagle Pointe Recreation Center, and two at the Civic Center. Two charging stations having been in place at the Bison Ridge Recreation Center since 2019. Safety measures will be in place in the building parking lots during construction, including barricades, caution tape, and traffic control signs. Expected to be complete by the end of March (contingent upon weather), the installation of five Level II Dual Port 80 Amp Electric Vehicle Charging Stations directly supports the city's Sustainability Action Plan.

### Cram the Cruiser returns Sunday, Feb. 25!

Each year during the city's Spread the Love food drive, Commerce City police officers join the effort by encouraging residents to fill police vehicles with donations of peanut butter and jelly for local food banks. Officers will be posted in front of both King Soopers stores in Commerce City for the event to visit with shoppers and give kids a look at their patrol vehicles while they collect donations for local food banks.

WHEN: Sunday, Feb. 25, 9 a.m. - 1 p.m.

WHERE: Commerce City King Soopers locations (4850 E. 62nd Ave. and 15051 E. 104th Ave.)

Nonprofit organizations serving Commerce City residents are invited to apply for grant funding from the Quality Community Foundation! QCF grants provide funding for a wide variety of programs and services in the city, including emergency housing for homeless families, volunteer services and meals for seniors, advocacy and emergency assistance for victims of domestic violence, health care, mental illness, and local food banks. To be eligible, nonprofits must have 501(c)3 status, address the needs of Commerce City residents, and demonstrate sound fiscal management. Grant applications are due Friday, March 1. ## Business/Economic Development



- Staff reached out to an indoor entertainment concept to request a meeting to learn more about the concept and discuss the possibility of a location in Commerce City. The concept offers sports simulation technology, food and beverage, and other recreational offerings.
- Staff received an update on a prospective retailers expansion plans in Colorado for targeted categories including general merchandise, home improvement, indoor entertainment concepts, and grocery. Staff provided additional information on potential sites as result of update outreach.
- Staff is working with a landscape equipment dealer on an incentive application for their new 27,000 square feet facility. They confirmed that the new facility will be the largest operation for the company in Colorado.
- Staff received an update on a proposed industrial development that will offer a 28,000 square feet multi-tenant building along E. 96<sup>th</sup> Ave. The building will feature up to 11 tenant spaces that will feature 30-foot high ceilings.
- Staff provided business liaison and business attraction services for the E. 104th Ave. Commerce Park development.

- Staff received an update on a proposed 4.8 acre commercial development along E.120<sup>th</sup> Ave. The project will offer four pad sites allowing for potential buildings for tenants ranging in size from 2,300 square feet to 4,700 square feet.
- Staff met with the North Metro Small Business Development Center leadership to identify opportunities for improved collaboration on small business support and business retention and expansion efforts. A process for business resource referrals was put into place. The North Metro SBDC reported they are kicking off a strategic planning process and expressed interest in a regional business retention and expansion collaborative to help inform that effort.
- Staff provided business liaison support for Boise Cascade.
   Boise Cascade has secured a Temporary Certificate of
   Occupancy for its office space and is working toward a
   Temporary Certificate of Occupancy for the remainder of its
   127,000 square foot facility.
- Staff partnered with the URA to conduct a business visit with a business owner in Derby. The business owner expressed interest in expanding to a second location, expanding hours at their current location, and exploring expansion of food offerings. Staff explored opportunities for support of these projects and will continue to remain engaged with business ownership. The need for a Derby-focused community group was also discussed and the business owner expressed support.
- Staff met with the communications team to discuss opportunities to improve the process for business announcements, press releases, and related tools.
- Staff met with URA staff to support the URA's market study of opportunities for the designated public building at Mile High Greyhound Park. Staff is supporting alignment with workforce and economic development initiatives.
- Staff met with a business owner in Derby to discuss revitalization efforts, arts and culture opportunities, and the need for a Derby-focused community group.



### **Preservation and Safety**

 The city's Asphalt Crack Repair Project continues to move forward. Last week, nine repairs were completed in the Buffalo Run East neighborhood.

### Engineering

- Staff was informed the Colorado Department of Transportation (CDOT) approved a Highway Safety Improvement Grant (HSIP) in the amount of \$1.2 million for the Highway 2 Median Project.
- A project update meeting was held for the E. 72nd Avenue and Monaco Street Intersection Project.
- The weekly project update meeting with representatives from the Buffalo Ridge Metro District occurred for the widening of E. 120th Avenue between Chambers Road and Buckley Road.
- Staff attended the Adams County Sub-regional Forum meeting where a presentation was given on the City's application for a Rebuilding American Infrastructure with Sustainability and Equity Grant (RAISE) for the E. 88th Avenue Widening Project between I-76 and Highway 2.
- A project update meeting was held for the E. 96th Avenue widening project between Chambers Road and Tower Road. The first phase of the project is planned to be advertised for bids this spring.
- A project update meeting was conducted for the Highway 2 Corridor Study.
- Multiple staff members from several divisions within Public Works presented to the Latino Engagement Taskforce (LET).
   Topics included transportation and traffic safety, refuse and recycling collection services, and Parks and Streets Maintenance Division functions.

### **Parks**

- Staff performed snow operations over the weekend on City properties and assisted the Commerce City Snow Guardians Program. This included shoveling City building walkways and sidewalks.
- Staff removed snow and ice from the Pioneer Park ballfields in preparation for upcoming ballfield use.
- Staff began to install bi-lingual dog station signs at two locations. Five signs were installed at Fronterra Park, and four signs were installed along the Second Creek Trail.

- Staff removed trash and debris from the right-of-way at E. 104<sup>th</sup> Avenue, E. 112<sup>th</sup> Avenue, Chambers Road, and Potomac Street.
- Staff began installing new park benches, picnic tables, and trash can canisters at Monaco Vista Park, Rose Hill Grange Park, and Olive Park in preparation for the upcoming spring and summer seasons.
- Staff removed tree debris and trash from Fairfax Park and will continue to monitor the area on a daily basis.

### **Streets**

- Staff responded to the 9<sup>th</sup> snow storm of the season this past weekend. Teams were called out Friday night and began cleaning snow at 9 p.m. and concluded operations around 5 a m
- Pavement Teams were dispatched to repair approximately 83 potholes in various locations throughout Commerce City.
- Traffic Teams completed removing holiday decorations from City streets.
- Sweeping Teams swept E. 60<sup>th</sup> Avenue, E. 64<sup>th</sup> Avenue, Holly Street, and Monaco Street to highlight most targeted areas.
