## Background

- Current curbside refuse contract expires at end of 2019
- Public Works advertised RFP on August 7<sup>th</sup>
  - –Bids were due on September 3<sup>rd</sup>



# Annual Program Cost(s)

2016	2017	2018
\$1,614,357	\$1,695,630	\$1,817,238

- 2019 Projected Cost(s) \$2,088,067
  - Monthly rate for each unit is \$10.77
    - Includes base price plus adjustment for recycling extraordinary cost
  - Based on current program elements
    - Includes annual contractual 2.7% CPI increase
    - Includes estimated 50 additional units per month

# 2020 Projected Program Cost(s).

- 2020 Potential Cost Increase
  - Predicated on price increases (per unit/per month) and assumes same level of service/program elements and with the continued growth of 50 units per month.

2020 Unit Cost/Per Month	Amount of Increase	2020 Projected Cost
\$13.74	27.5% increase	\$2,856,172
\$16.00	Lowest Comparable (Northglenn)	\$3,323,314
\$23.60	(Average)	\$4,894,234
\$30.77	Highest Comparable (Louisville)	\$6,376,273

# Base Bid Elements

- Base Bid:
  - Two (2) 96 gallon totes at each residence
    - One (1) tote is for weekly trash service
    - One (1) tote is for every other week recycling service
    - Recycle tote may be switched out for a second trash tote no more than once a year at no additional cost
      - Second trash tote would be picked-up weekly
  - Approximately 500 residences are served by dumpster service
  - Minimum of 4 annual large item pickups for all residences
  - Programmed dumpster and tote service at city facilities such as buildings/parks

\* Bid amount includes \$84,865 for municipal dumpster service. Bidder #3 included that service for no additional charge. Bidder #1 did not provide a price for that service.

## Base Bid w/Bid Alt #1 Results

• Bid Alt #1 - Provide recycling pickup service weekly instead of every other week

Bid Alt #1 Price/Unit/Month	\$38.00 (Increase of \$8.00 over base bid)	No Bid	\$21.72 (Increase of \$4.74 over base bid)

Estimated Price per Year for Dumpster Service	\$21,120.00	No Bid	\$10,848.00

## Additional Incentives Offered By Bidders

- Bidder #2 proposed they will double disposal fee revenue rebate. Total value of about \$17,000 in 2020.
- Bidder #2 proposed paying for two additional large item drop offs where residents can drop off items at a drop off site for free.
- Bidder #2 provided a bid for a 7-year contract
   Contract rates saves City \$289,380+ over
   7 years (compared to 5-year contract rates).

# Recommendation(s)

- The Internal Selection Committee reached consensus on the following;
  - Recommend Bidder #2 Base Bid (5-year contract)
    - Bidder #2 is the low bidder by a minimum of \$711,658.16 per year.
    - Qualitative aspects of the bids did not outweigh the quantitative aspects (and additional incentives).

- Selection of Contractor
  - September/October 2019
- Coordinate w/Selected Contractor
  - October December 2019
- Begin New Contract
  - January 2020
