Discussion of Public Safety Issues

Mayor Huseman stated they called for the special meeting in order to discuss several public safety incidents that took place over the weekend.

Interim City Manager Tinklenberg provided opening remarks to state that due to ongoing investigations related to the incidents, details of the incidents may not be fully discussed during the meeting.

Chief Nichols provided an overview of the incidents, including circumstances prior to the incidents taking place and the police department's response to the incidents.

City Attorney Sheesley provided council with a summary of a proposed ordinance that will come before council that will address parking and curfews in city parks and properties.
