#### **REQUEST**

Approve a resolution awarding a construction contract to Colorado Designscapes Inc. in the amount of \$470,100.00 for the construction of three new softball fields.

#### **BACKGROUND**

Commerce City Parks, Recreation and Golf is planning to construct three new softball fields on 27J school properties (Turnberry Elementary School, Stuart Middle School, and Second Creek Elementary School). This project is a joint effort with the School District, and funds were previously transferred from the Commerce City Brighton School District Use Tax Fund (CCBSD) to the CIP fund. These new fields will be programmed as practice fields for children who participate in the youth baseball programs offered through Parks, Recreation and Golf. A Request for Bids for construction of these fields was released in Q1 of 2025, four bids were received, with Colorado Designscapes Inc. as the selected contractor to complete the project. Following issuance of notice to proceed, the contractor will have approximately 120 days to complete the project.
