*Mr. Fenton testified to his educational and employment history. He stated that he is the owner/manager of LP Capital and bears sole responsibility for the business and its day-to-day operations. This is his first marijuana business and he intends to hire individuals who have industry experience. The materials will come from licensed growers and infused into smokeables and vapor products. The business will not be open to the public and onsite consumption will be prohibited. In response to questions posed by the city, Mr. Fenton stated that he has no financial interest in Dallas Street Holdings; however, he does have signature authorization. In regards to his public consumption ticket out of Boulder, he stated that he was a few feet of his property and received a ticket. Since that time he has educated himself on public consumption laws.*

*Mr. Romero testified to his educational and employment history. He stated that he will be responsible for the daily operations and trainings and was the person who*

*circulated the petition to establish the desires of the neighborhood.*

*There being no one from the public in attendance, Hearing Officer Ablao closed the public hearing and stated she will issue her findings within 30 days.*
