



TRAINING

Total hours of training in 2018: 17,287

- Includes: 855 hours of hazardous materials training, 2097 hours of EMS training, and 2076 hours of specialty training (SACFD Technical Rescue Team, Hazmat Team, Wildland Team
- Received 54 newly issued Colorado Division of Fire Prevention and Control certifications.

Significant Training Events:

- Conducted Blue Card Incident Command Certification Lab for 19 individuals
- Provided Officer Bootcamp for 9 individuals seeking Acting Company Officer designation (40-hr course covering tactical skills and administrative duties of fire department supervision)
- Participated in the CPFF Honor Guard Academy. During the 40-hour course, 8 participants learned marching skills, flag presentation, and funeral honors with law en-forcement and fire agencies from the region
- · Conducted Driver Operator Pumper Academy for 12 individuals seeking Driver Operator certification (80-hour course covering all aspects of engine operations including driving, pumping, drafting, etc.)
- Provided a National Wildfire Coordinating Group (NWCG) S130/190/L18040 hour course for wildland firefighter certification instructed by Rocky Mountain Arsenal/U.S. Fish and Wildlife
- · Provided A.L.I.C.E. (Alert, Lockdown, Inform, Counter, Evacuate) classes providing preparation to proactively handle the threat of an aggressive intruder or active shooter event at the firehouse or on a "routine" incident
