ORDINANCE NO. 2534

FIRST READING OF AN ORDINANCE AMENDING THE 2023 BUDGET OF THE CITY OF COMMERCE CITY, COLORADO BY THE RECOGNITION OF THE ADAMS COUNTY OPEN SPACE GRANT FOR A SINGLE RIDER GOLF CART IN THE AMOUNT OF \$13,250 AND THE AUTHORIZATION OF THE EXPENDITURE THEREOF.

WHEREAS, the City of Commerce City has been awarded a Adams County Open Space Grant in the amount of \$13,250 to fund the expenses of providing a Single Rider Golf Cart; and

WHEREAS, in November 1999, the citizens of Adams County passed a county-wide one-fifth of one percent Open Space Sales Tax (the "Tax"); and

WHEREAS, in November 2004, the citizens of Adams County reauthorized the Tax and increased it to one-fourth of one percent; and

WHEREAS, in November 2020, the citizens of Adams County authorized the permanent extension of the existing county-wide sales tax of one-fourth of one percent for the continuing purpose of preserving open space and creating and maintaining parks and recreation facilities; and

WHEREAS, the majority of the revenues collected are distributed to qualifying jurisdictions through a competitive grant process; and

WHEREAS, on March 31, 2023, the City of Commerce City applied for an Adams County Open Space Grant to provide a Single Rider Golf Cart for the City of Commerce City's Parks Recreation & Golf Department and

WHEREAS, on June 27, 2023, Adams County awarded the City of Commerce City an Adams County Open Space Grant to complete the Project; and

WHEREAS, Adams County awarded 69.92% of the total projects cost, not to exceed \$13,250.00.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

- **SECTION 1.** The recitals to this ordinance are incorporated as findings of the City Council. This ordinance is found to be necessary for city improvements, establishing, and maintaining the quality of life in a community, ensuring the health of families and youth, and contributing to the economic and environmental well-being of a community and a region.
- **SECTION 2.** An amendment is made to adopt and allocate funds for the Single Rider Golf Cart from the Adams County Open Space Grant in the amounts of \$13,250.

SECTION 3. This ordinance is in the best interests of the City and shall be effective immediately upon passage on second and final reading.
