AN ORDINANCE AMENDING THE LEGAL DESCRIPTION ATTACHED AS EXHIBIT "A" TO ORDINANCE AN-233-15-16 REGARDING PROPERTY LOCATED AT 10655 EAST 120TH COURT, COMMERCE CITY, COLORADO.

WHEREAS, the property described on Exhibit "A" to Ordinance AN-233-15 was annexed to the City of Commerce City on April 6, 2015 and said legal description is attached to this ordinance as Exhibit "A"; and

WHEREAS, the legal description attached as Exhibit "A" is incorrect and needs to be amended; and

WHEREAS, the correct legal description for the annexation in Ordinance AN-233-15-16 was correctly shown on the Annexation Map for Annexation 233-15 which map is filed in the records of the Clerk and Recorder of Adams County, Colorado; and

WHEREAS, the correct legal description for the property annexed to the City of Commerce City in Case AN-233-15 is attached to this ordinance as Exhibit "B"; and

WHEREAS, the corrections made in the legal description for the annexation in Case AN-233-15 are minor and do not require a new annexation procedure for the property annexed to the City of Commerce City in Case AN-233-15.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO AS FOLLOWS:

SECTION 1. The legal description for the property in Ordinance AN-233-15 is amended as set forth in Exhibit "B" and Ordinance AN-233-15 is amended by substituting thereto the legal description attached to this ordinance as Exhibit "B" and deleting from Ordinance AN-233-15 the legal description described on attached Exhibit "A".
