

**RESOLUTION APPROVING THE
SECOND SUBSTANTIAL AMENDMENT TO THE 2019 ANNUAL ACTION PLAN**

WHEREAS, the City of Commerce City, CO (“City”) is an entitlement jurisdiction and receives funding from the U.S. Department of Housing and Urban Development’s (“HUD”) for the Community Development Block Grant (“CDBG”) Program;

WHEREAS, City Council approved the submittal of the 2019 Annual Action Plan (“2019 AAP”) to HUD on July 1, 2019, and HUD-approved the use of funds in September of 2019;

WHEREAS, the City first substantially amended the 2019 AAP on June 15, 2020, to receive a special allocation of \$246,587 in CDBG funding from HUD (“CDBG-CV1”) to be used to prevent, prepare for, and respond to the coronavirus pandemic (“COVID-19”). This first special allocation was authorized by the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Phase 1, Public Law 116-136;

WHEREAS, the City is eligible to receive a second special allocation of CDBG funding in the amount of \$220,453 from HUD (“CDBG-CV3A”) to be used to prevent, prepare for, and respond to COVID-19. This second special allocation was authorized by the CARES Act, Phase 3A, Public Law 116-136;

WHEREAS, pursuant to the City’s Citizen Participation Plan and in accordance with 24 CFR 91.105 of the federal regulations relative to citizen participation for Community Planning and Development Programs, and the expedited waivers and procedures allowed under the CARES Act, the City conducted the necessary public notifications and provided for public input to complete the process of substantially amending the 2019 AAP; and

WHEREAS, the City has prepared the second substantial CARES Act amendment to the 2019 Annual Action Plan, which was available for 12-days on the City’s official website of public comment from December 9, 2020, through December 21, 2020, and desires to approve and submit the Second Substantial Amendment to the 2019 AAP to HUD for approval;

WHEREAS, the City conducted a virtual public hearing on December 21, 2020, and considered all matters presented on this Second Amendment to the 2019 AAP;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY AS FOLLOWS:

1. The City Council hereby approves the Second Substantial Amendment to the 2019 AAP.
2. The City Manager or his designee is hereby authorized to take all actions necessary to submit and obtain approval from HUD for the Second Substantial Amendment to the 2019 AAP.
