REQUEST

Approve a budget ordinance to amend the 2025 budget of the City of Commerce City ("City") to recognize Natural Disaster Mitigation Enterprise grant funds in the amount of \$300,000 for wildland fire mitigation activities by the Emergency Management Division of the Commerce City Police Department.

BACKGROUND

In 2025, the City applied for \$300,000 in Natural Disaster Mitigation Enterprise Grant funds for wildland fire mitigation activities. The City was awarded \$300,000 over three years for funding to hire a contractor to construct a fire break and maintain vegetation to a height of four to six inches in seasons of high fire risk. The Emergency Management Division will collaborate with internal departments and the South Adams County Fire District to determine the highest-risk areas to implement the project.
