 - May 2024-Soyla Rodriguez hired as first Commerce City Municipal Probation Officer
 - 440 cases assigned to Probation
 - 295 cases successful
 - 17 cases unsuccessful
 - 128 cases moved to 2025 roster

FRESH START EVENT

- Event held on 10/16/24 and provided opportunity for defendants with outstanding warrants, fines, or other compliance issues to get cases back on track.
- To continue to be held annually in the future



INDIGENT DEFENSE COUNSEL

- \$32,834.46 paid in 2024
- Grant funds used to pay Court Appointed Attorneys for all qualifying first appearances
 - 82 1st appearances in 2024
 - \$4300.00 paid from 1st appearance grant funds in 2024
- Conflict free counsel pursuant to SB-203



INTERGOVERNMENTAL AGREEMENTS

- North Metro Youth Diversion Program
 - Adams County Juvenile Assessment Center Summit and Task Force formed September 2023 due to closure of The Link; North Metro Youth Diversion Board disbanded October 2024.
 - Juvenile Defendants may still be offered Diversion upon successful completion of classes/useful public service.

• Adams County Detention Facility

 Video appearances of persons in custody –continued to utilize WebEx and Zoom platforms in 2024.

- Judicial Conferences presiding and substitute judge attended in 2024.
- Quarterly meetings with Colorado Supreme Court Justices
- Quarterly meetings for Adams/Broomfield County Municipal Judges



PENDING LEGISLATION

• SB25-062

-This bill adds the failure to appear and contempt of court for the failure to appear prohibitions to the list of state laws that cannot be superseded by a charter or ordinance enacted by a home rule city.

• HB 25-1147

-Concerning measures to ensure that Municipal Court defendants are subject to similar conditions as State Court defendants.

 - Increased convenience for case parties and reduction in FTA rate
 - Court hearings & business conducted 100% virtually on building closure dates

- Implementation of Court Survey
 - Available in paper and online format
 - Positive results



LANGUAGE TRANSLATION

- Implementation of LanguageLine for phone/video interpretation
 - Available for 240+ languages
 - Additional convenience & significant cost savings
- Budget approval for increased in-person interpreter availability beginning 1/1/25
 - In-person Spanish interpreters available every court date
