## A RESOLUTION AWARDING THE CIPP PROJECT FOR CONSTRUCTION OF THE MUNICIPAL SERVICES CENTER (MSC), EAGLE POINTE RECREATION CENTER, AND CIVIC CENTER ELECTRIC VEHICLE CHARGING STATIONS TO HIGH PLAINS ENERGY, INC. DBA PINNACLE ELECTRIC & CONSTRUCTION CORP. 2023-19-PW

WHEREAS, the City of Commerce City ("City") desires to meet a community demand for electric vehicle chargers, to lower the City's carbon footprint, to modernize the City's infrastructure, to accommodate future City fleets incorporating electric vehicles, and to encourage employee adoption of electric vehicles;

WHEREAS, the City will collaborate with the Contractor, who will install Level II Electric Vehicle Charging Stations at the Municipal Services Center, Eagle Pointe Recreation Center, and the Civic Center with this Project, as described by the City's Public Works Department, consistent with the scope of work detailed in 2023-19-PW Request for Proposals: Municipal Services Center (MSC), Eagle Pointe Recreation Center, and Civic Center Electric Vehicle Charging Stations ("Project");

WHEREAS, the City has engaged in a formal competitive bidding process consistent with applicable requirements to select a contractor to complete the Project, and City staff has determined that the lowest responsive and responsible bidder whose bid provides the best value to the City is High Plains Energy, Inc. dba Pinnacle Electric & Construction Corp. ("Contractor"); and

WHEREAS, the cost of the Project to the City will exceed \$250,000.00 and, pursuant to the City's procurement policies and the City Manager's commitment to the City Council, the City Council must approve any procurement in excess of \$250,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

**SECTION 1. Findings.** The recitals to this resolution are incorporated as findings of the City Council. This resolution is found to be necessary for the preservation of the public health, safety, and welfare and in the public interest. Specifically, the City Council hereby finds and determines that the award of the contract for the Project to the Contractor is and shall be in the best interests of the residents of the City.

**SECTION 2. Award of Contract**. The award of the contract for the Project to the Contractor is hereby approved subject to successful finalization of an appropriate contract on terms acceptable to the City Manager. This resolution shall not be deemed to grant any right or interest in the award of a contract to High Plains Energy, Inc. dba Pinnacle Electric & Construction Corp. All rights and interests shall be defined exclusively by the terms and conditions set forth in the written contract.

**SECTION 3. Authorization to Negotiate.** The City Manager is hereby authorized to negotiate and finalize the details of a contract with the Contractor, including final pricing and payment terms.

**SECTION 4. Execution and Attestation.** Upon successful finalization of the contract and approval as to form by the City Attorney, the City Manager is hereby authorized to execute, and the City Clerk to attest, the contract on behalf of the City.
