I understand the importance of supporting, educating, and creating community through countless acts of community service and this is why I am applying for Commerce City Council Ward III. I come from local indigenous communities and know how crucial representation and equity with analysis is to my community impacted by local state and federal agencies balancing modern solutions and compassionate leadership as a priority. Equity priority is needed to analyze local projects, investments, and planning for current and future generations, learning from the past generations impacts to Commerce City, and Colorado.

Colorado is the land of the Ute, Cheyenne, Arapahoe, and 48 tribes, including mine that still live, work, go to school, and thrive in what is now Commerce City. We know the old names of rivers and landmarks on the front range before Colorado was a state. Colorado has been the intersection of our continent for generations of trade, development, and cultural exchanges, that should still and always work with prioritizing equity and analysis of historical, economic, and social contexts to help enrich and expose the front ranges important history to help future generations establish a foundation to build with real diversity and inclusion where our state has developed these natural connections.

Challenges crucial to address, is the misdirection of past generations to exclude community health based standards and protections in a land port city where industry is so influential, there needs to be more equity analysis of cumulative impacts to residents to truly be in the best interest for the health and safety of people living so intertwined with industries. The second is the current booming development to also work with contexts of cultural and trauma sensitivity as an equity priority, to not perpetuate harmful "business as usual" investments in land development, education, and housing to recreate comprehensive knowledge on what is going to be the most sustainable and renewable development to not overburden already known disproportionately impacted communities in Commerce City. Last is the crucial need for education and reeducation in new transportation sectors that can revolutionize Commerce City as a port city and address its decades old known health impacts from several mediums of particulate pollution. We have the opportunity to incentivize renewable and sustainable industries and learn where they did or didn't work in other states to implement changes away from harmful industries to address public health and safety. Adams County and Commerce City have large diverse populations, growing a workforce is another opportunity to include education in a transformative way by offering trade schools, adult education, and apprenticeships to disproportionately impacted communities to authentically address equity and grow a strong community. Commerce City also has the opportunity to link Denver and the front range with healthier modes to transportation and sustainable affordable housing developments with more community involvement of how land use can better serve local

communities and geography to create policy and rulemakings others can model after for community made protections and influence.

Honestly, I don't have any concerns serving as a council member because I'll always be here to support, educate, and maintain safe and brave spaces for equity, serving on council is another avenue to accomplish this ultimate goal, for and with the community. I unfortunately have not had the opportunity to work in Commerce City Civic Academy but have worked in other spaces with Energy Defense Fund and Energy Foundation to develop protecting civil liberties through social and environmental injustice including travel to Washington DC to protect indigenous communities. I now live in a home I own with my husband in Commerce City for 5 years, after serving with him while he was in the Navy as a Nuclear Engineer for nine years including traveling from east coast to west coast with our two sons. One favorite place for my family is El Jardín restaurant in Commerce City, rich with food, culture, and community. I'm always grateful to see how strong the community has been here including after wars and environmental harms, with one restorative example being the Rocky Mountain Arsenal, proving transformative preservation of our land and resources can be done with respect and inclusion in the modern identity with cultural enrichment.
