Hello,

I am a homeowner in the Eastpoint neighborhood. We have been experiencing higher rates of crime recently, and do not need to attract more criminal activity to this area and neighborhood. The residents here are asking for nicer developments (restaurants, a target store, trader joes, etc.), not dispensaries. Dispensaries tend to correlate with increased levels of crime. Additionally, there are already dispensaries nearby at Tower Road and Pena. In an area with so many young families, this is not what we need. Please reconsider your decision.

In addition, I heard that many letters (87+) have been sent, and a letter writing campaign has been implemented in support of this measure. This support appears to be artificial, coming from outside influences that do not reflect what the local residents want in the area. I, along with our neighbors, were given no notice regarding this public hearing and subsequent vote of this measure, including the fact that it is taking place today (April 1st). If we knew about this ahead of time, we would have likely started a petition to collect signatures of those opposed to the measure. I believe that the vast majority of homeowners in the Eastpoint neighborhood (and adjacent developments such as Reunion) would be greatly opposed to this measure for the reasons listed above. Please reconsider this action and decision.

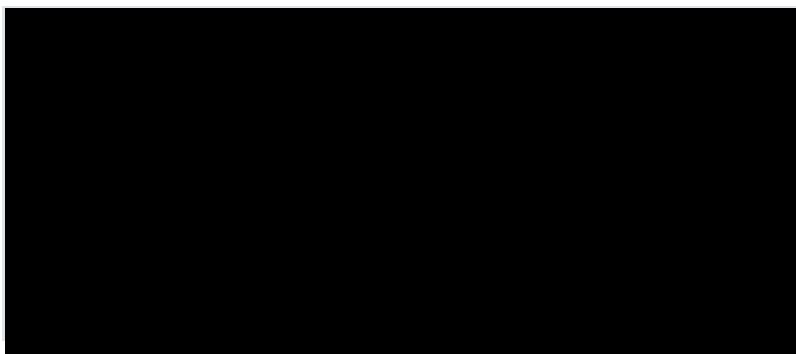
I am a Reunion homeowner and I oppose the rezoning and the building of a dispensary in Reunion.

We moved here from Denver and witnessed the impact first-hand. We used to live in Lowry and we experienced several home invasions and murders near us. Homeless camps would spring up near the dispensaries and crime "clusters" would also be located near them.

I have also had my brother knocked off an overpass by a high driver that was under the influence of marijuana. His heart stopped three times before he stabilized. He suffered a closed head injury resulting in long-term brain damage, crushed pelvis, broken jaw, crushed ribs, organ lacerations and internal bleeding, and spent almost nine months in the hospital-the first three in intensive care. He ultimately survived, but was no longer able to be employed by NASA (he was a computer programmer and a graduate of Rice University and MIT) and now he is pretty close to being a Ward of the State of Texas.

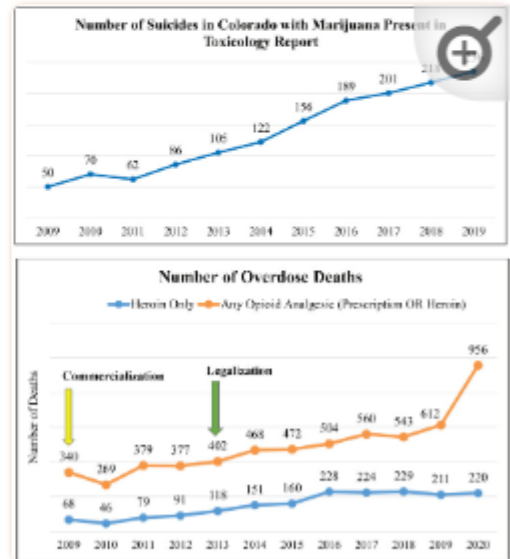

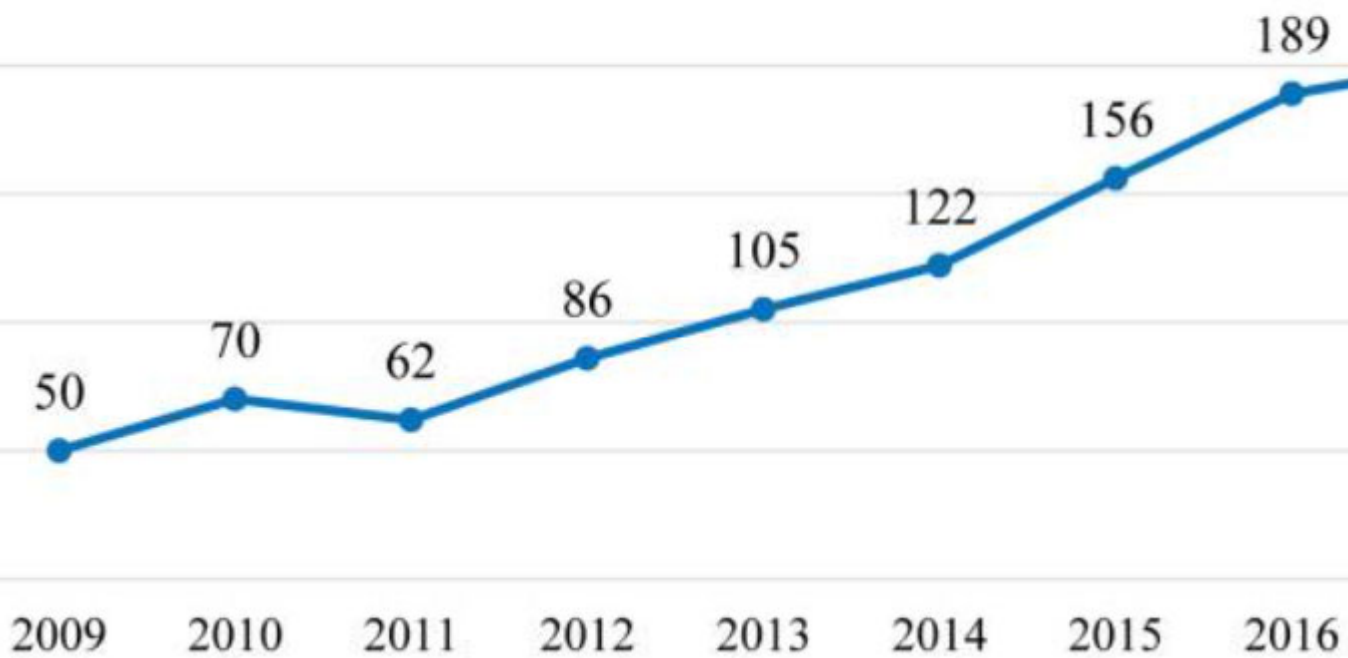

Medical and recreational marijuana legalization is destroying the health and soc overdoses, ER visits, hospitalizations, and domestic and street violence due to c revenues are an anemic 0.98% of the 2021 state budget. Tax revenues are dwa law enforcement, automobile and industrial accidents, and increased school crim marijuana from being legalized in 2022.

On a professional level, I also work for a very large organization that deals with location selectors and large retail chains, fast food, hospitality, and grocery chains. Commerce City already has had a nightmare scenario of luring new businesses to Commerce City, let alone the northeast area of the city. Adding a dispensary will destroy any chance of development of those types of businesses nearby. Most locations selectors are given DIRECT INSTRUCTIONS not to open near liquor stores, pawn shops, or **dispensaries**. I have personally confirmed this with multiple potential customers.

**Allowing this dispensary to go through, especially across the street from a middle school, will permanently blight that intersection and will create long-term negative impact to our community.**

One additional point: **my girlfriends brother died in his sleep after smoking MJ from a Colorado dispensary. Let that sink in.... state regulated dispensary and he died suddenly-and it was before Covid-19.**

Dear City Council,

I'm writing to express my support for the proposal to re-zone the retail plot 104<sup>th</sup> and Tower to accommodate the establishment of a cannabis dispensary. Having lived in our neighborhood for close to two decades, I've seen the community grow and change in numerous ways, and I believe this initiative is a positive step forward that provides economic growth and offers safer alternatives to alcohol to our neighbors.

In my conversations with representatives from Social Cannabis, particularly the local mother who is part of their team, I've been encouraged by their commitment to being responsible members of our community. Their efforts to prevent underage marijuana purchases and their willingness to engage with local authorities demonstrate their dedication to operating in a safe and respectful manner. Their idea of holding regular "good neighbor" meetings further demonstrates their openness to addressing any concerns or feedback from residents and shows their dedication to being a part of the community rather than just another storefront.

On a personal note, my own struggles with alcohol addiction for nearly two decades, have made me acutely aware of the need for safer recreational alternatives. Marijuana has played a significant role in my recovery, offering me a way to relax and unwind with friends and family without the harmful effects of alcohol and helping me stay alcohol-free for going on 5 years. Having heard similar stories from countless others who had overcome addiction during my recovery journey, I believe that providing access to safer alternatives like marijuana can benefit many others in our community who may be facing similar challenges.

This was made especially clear to me throughout my studies as I completed a Bachelor of Arts in Human Services with a Substance Abuse Counseling concentration, where numerous discussions I had with professors and recovery professionals alike affirmed the importance of allowing access to safer alternatives like marijuana. This is especially true at a time when, as recently reported by the Denver Post<sup>[1]</sup>, Colorado has some of the lowest alcohol taxes in the United States and one of the highest levels of alcohol-related deaths nationwide<sup>[2]</sup>.

Moreover, the economic benefits of allowing the dispensary to open in our neighborhood cannot be overstated. At a time when our community is clearly in need of additional revenue sources as our neighbors in Brighton and Green Valley Ranch enjoy an economic boom, the potential tax revenue generated by the cannabis dispensary could provide a much-needed boost. Additionally, it would introduce diversity to our local business landscape, offering residents more choices and contributing to the overall vibrancy of our neighborhood.

After years of having little more than nail salons and dentist offices opening in the area, Social Cannabis' operations would provide some long-overdue diversity. While I understand that there may be concerns from some members of the community, I believe it's important to consider the potential benefits of this proposal. I also worry that allowing a vocal minority of neighbors who are opposed to the dispensary to effectively scare off the business will make our community unappealing to other potential commercial operations, further limiting the number and types of businesses that open in Reunion.

In conclusion, I urge you to consider the positive impact that the re-zoning proposal for the cannabis dispensary at 104<sup>th</sup> and Tower could have on our neighborhood. Thank you for your attention to this matter, and I hope for your support in moving this proposal forward.

I am a very concerned parent and neighbor that just caught wind that a Marijuana Dispensary is being considered and planned for the Tower and 104th Corner. This is absurd and essentially negligence considering the current drug problem our kids and generation is facing and that this dispensary would be only a few feet from the new STEAD High School. Even though marijuana and vaping is legal, it is well-documented that these are gateway drugs to a much more profound and rampant drug problem. Dear City Council,

I'm writing to express my support for the proposal to re-zone the retail plot 104<sup>th</sup> and Tower to accommodate the establishment of a cannabis dispensary. Having lived in our neighborhood for close to two decades, I've seen the community grow and change in numerous ways, and I believe this initiative is a positive step forward that provides economic growth and offers safer alternatives to alcohol to our neighbors.

In my conversations with representatives from Social Cannabis, particularly the local mother who is part of their team, I've been encouraged by their commitment to being responsible members of our community. Their efforts to prevent underage marijuana purchases and their willingness to engage with local authorities demonstrate their dedication to operating in a safe and respectful manner. Their idea of holding regular "good neighbor" meetings further demonstrates their openness to addressing any concerns or feedback from residents and shows their dedication to being a part of the community rather than just another storefront.

On a personal note, my own struggles with alcohol addiction for nearly two decades, have made me acutely aware of the need for safer recreational alternatives. Marijuana has played a significant role in my recovery, offering me a way to relax and unwind with friends and family without the harmful effects of alcohol and helping me stay alcohol-free for going on 5 years. Having heard similar stories from countless others who had overcome addiction during my recovery journey, I believe that providing access to safer alternatives like marijuana can benefit many others in our community who may be facing similar challenges.

This was made especially clear to me throughout my studies as I completed a Bachelor of Arts in Human Services with a Substance Abuse Counseling concentration, where numerous discussions I had with professors and recovery professionals alike affirmed the importance of allowing access to safer alternatives like marijuana. This is especially true at a time when, as recently reported by the Denver Post<sup>[1]</sup>, Colorado has some of the lowest alcohol taxes in the United States and one of the highest levels of alcohol-related deaths nationwide<sup>[2]</sup>.

Moreover, the economic benefits of allowing the dispensary to open in our neighborhood cannot be overstated. At a time when our community is clearly in need of additional revenue sources as our neighbors in Brighton and Green Valley Ranch enjoy an economic boom, the potential tax revenue generated by the cannabis dispensary could provide a much-needed boost. Additionally, it would introduce diversity to our local business landscape, offering residents more choices and contributing to the overall vibrancy of our neighborhood.

After years of having little more than nail salons and dentist offices opening in the area, Social Cannabis' operations would provide some long-overdue diversity. While I understand that there may be concerns from some members of the community, I believe it's important to consider the potential benefits of this proposal. I also worry that allowing a vocal minority of neighbors who are opposed to the dispensary to effectively scare off the business will make our community unappealing to other potential commercial operations, further limiting the number and types of businesses that open in Reunion.

In conclusion, I urge you to consider the positive impact that the re-zoning proposal for the cannabis dispensary at 104<sup>th</sup> and Tower could have on our neighborhood. Thank you for your attention to this matter, and I hope for your support in moving this proposal forward.

I am a homeowner in the Eastpoint neighborhood. We have been experiencing higher rates of crime recently, and do not need to attract more criminal activity to this area and neighborhood. The residents here are asking for nicer developments (restaurants, a target store, trader joes, etc.), not dispensaries. Dispensaries tend to correlate with increased levels of crime. Additionally, there are already dispensaries nearby at Tower Road and Pena. In an area with so many young families, this is not what we need. Please reconsider your decision.

In addition, I heard that many letters (87+) have been sent, and a letter writing campaign has been implemented in support of this measure. This support appears to be artificial, coming from outside influences that do not reflect what the local residents want in the area. I am a Reunion homeowner and I oppose the rezoning and the building of a dispensary in Reunion.

We moved here from Denver and witnessed the impact first-hand. We used to live in Lowry and we experienced several home invasions and murders near us. Homeless camps would spring up near the dispensaries and crime "clusters" would also be located near them.

I have also had my brother knocked off an overpass by a high driver that was under the influence of marijuana. His heart stopped three times before he stabilized. He suffered a closed head injury resulting in long-term brain damage, crushed pelvis, broken jaw, crushed ribs, organ lacerations and internal bleeding, and spent almost nine months in the hospital-the first three in intensive care. He ultimately survived, but was no longer able to be employed by NASA (he was a computer programmer and a graduate of Rice University and MIT) and now he is pretty close to being a Ward of the State of Texas.

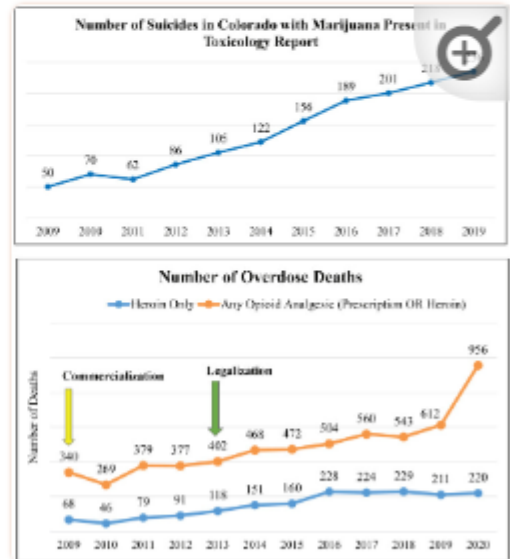

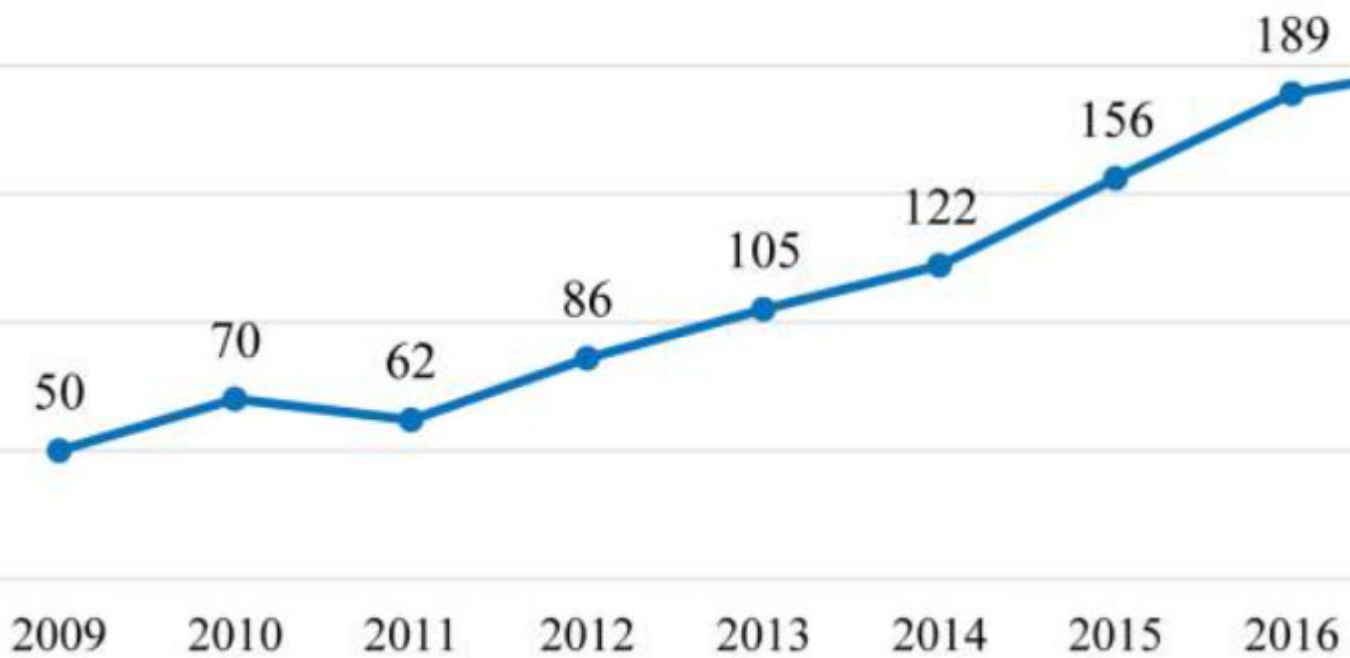

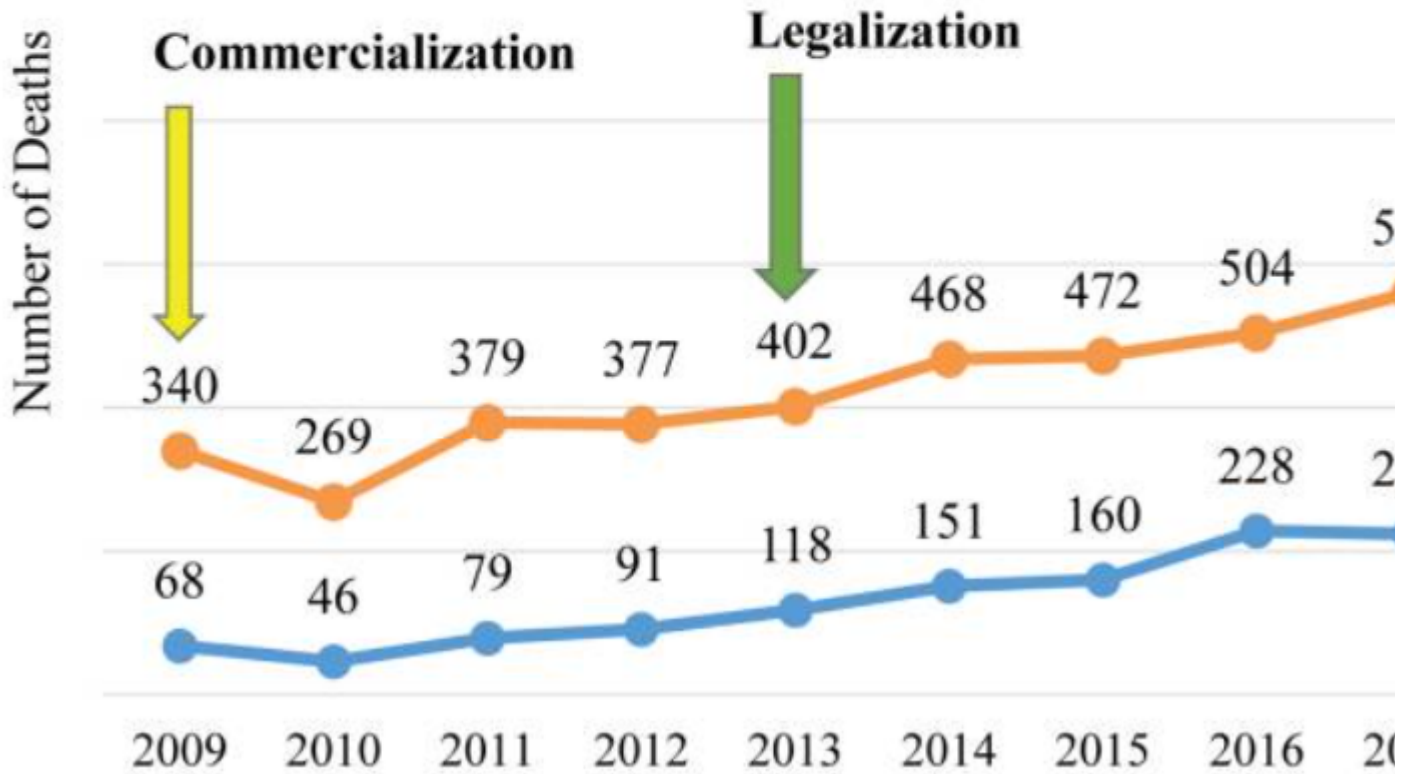


## Number of Suicides in Colorado with Marijuana Toxicology Report

Medical and recreational marijuana legalization is destroying the health and soc overdoses, ER visits, hospitalizations, and domestic and street violence due to c revenues are an anemic 0.98% of the 2021 state budget. Tax revenues are dwa law enforcement, automobile and industrial accidents, and increased school crim marijuana from being legalized in 2022.

On a professional level, I also work for a very large organization that deals with location selectors and large retail chains, fast food, hospitality, and grocery chains. Commerce City already has had a nightmare scenario of luring new businesses to Commerce City, let alone the northeast area of the city. Adding a dispensary will destroy any chance of development of those types of businesses nearby. Most locations selectors are given DIRECT INSTRUCTIONS not to open near liquor stores, pawn shops, or dispensaries. I have personally confirmed this with multiple potential customers.

Allowing this dispensary to go through, especially across the street from a middle school, will permanently blight that intersection and will create long-term negative impact to our community.

One additional point: my girlfriends brother died in his sleep after smoking MJ from a Colorado dispensary. Let that sink in.... state regulated dispensary and he died suddenly-and it was before Covid-19.
