

**A RESOLUTION OF THE CITY OF COMMERCE CITY APPROVING AN
INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF COMMERCE
CITY AND THE ADAMS COUNTY SHERIFF’S OFFICE FOR THE PROVISION OF
RECORDS TERMINAL SUPPORT**

RESOLUTION NO. 2023-138

WHEREAS, the City of Commerce City and the Adams County Sherriff’s Office, as Colorado governmental entities, are empowered pursuant to Article XIV, § 18 of the Colorado Constitution and C.R.S. § 29-1-201, *et seq.*, to cooperate or contract via intergovernmental agreement to provide functions, services, or facilities authorized to each cooperating government;

WHEREAS, the City of Commerce City entered into an intergovernmental agreement with the Adams County Sheriff’s Office in 2023, that allowed officers to receive administrative records services during the hours of 2200 and 0600;

WHEREAS, the governmental entities desire to enter into a new intergovernmental agreement for the same purposes; and

WHEREAS, the City of Commerce City finds it is in the best interest of the public health, safety, and welfare to approve the Intergovernmental Agreement Between the City of Commerce City and the Adams County Sherriff’s Office for the continuation of the Administrative Records Support Services in substantially the form attached to this Resolution as **Exhibit 1**, (the “IGA”);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

1. The recitals to this resolution are incorporated as findings of the City Council. This resolution is found to be necessary for the preservation of public health, safety, and welfare and in the public interest.
2. The Mayor and the City Clerk are hereby authorized and directed to sign and attest the Intergovernmental Agreement for Records Support Services from Adams County Sheriff’s Office, substantially in the form attached hereto attached as **Exhibit 1**.
3. The City Manager is hereby authorized to execute other documents and agreements consistent with accomplishing the purposes of the Intergovernmental Agreement for Record Support Services.

SECTION 1. Effective Date. This resolution shall be effective immediately upon adoption.

SECTION 2. Repealer. All resolutions, or parts thereof, in conflict with this resolution are repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.
