Park Fees Update - Permits to Consume

- Alcohol Permit to Consume – Resident
(per shelter or field) up to 750 people \$25.00
 - Alcohol Permit to Consume – Non-Resident
(per shelter or field) up to 750 people \$35.00
 - Alcohol Permit to Consume – Resident
over 750 people \$200.00
 - Alcohol Permit to Consume – Non-Resident
over 750 people \$250.00
- The fees for over 750 people are anticipated primarily for tournament rentals at Pioneer Park, or other organized events.



Trails Event Fees

All use fees are for up to 1,000 maximum participants:

- Resident based non-profit/charity event - \$2.00 per person
- Resident event - \$2.50 per person
- Non-Resident based non-profit/charity event - \$3.00 per person
- Non-Resident event - \$3.50 per person
- For Profit Based Events - \$4.00 per person
- Damage Deposit - \$1/per person, minimum \$100 deposit
 - Larger deposit may be charged for events that include alcohol, canopies, play structures, bands, etc.
