ORDINANCE NO. 2452

AN ORDINANCE AMENDING SECTIONS 21-5200, 21-5248, AND 21-11200 OF THE CITY OF COMMERCE CITY LAND DEVELOPMENT CODE RELATING TO THE LAND USE TABLE, DEFINITIONS, AND SUPPLEMENTAL REGULATIONS FOR LODGING ESTABLISHMENTS BY AMENDING THE LODGING ROOM MINIMUM, AND CREATING CONSISTENCY IN THE LAND USE TABLE.

WHEREAS, hotel development and travel needs have changed considerably since the adoption of the City of Commerce City Land Development Code ("LDC") in 2009 and the majority of new hotels contain less than 150 rooms due to financial costs and franchising requirements;

WHEREAS, the E-470 corridor provides convenient proximity to Denver International Airport and the greater Denver metro area and proximity to demand generators predicts hotel success;

WHEREAS, the City Council desires to attract lodging establishment developments to the City including the E-470 corridor through the reduction of existing room requirements for lodging establishments;

WHEREAS, the City Council considered revisions to the lodging establishment requirements of LDC § 21-5248 on October 17, 2022, in the context of proposed Ordinance 2423 on first reading and thereafter approved a conceptual amendment of that ordinance to revise the minimum number of rooms allowed in lodging establishments downward to 50 rooms;

WHEREAS, in order to incorporate this amendment, additional changes to the LDC were required, including an amendment to the definition of a Lodging Establishment to reflect City Council's desire for a minimum size requirement throughout the City of Commerce City;

WHEREAS, an amendment to the specific land use within the Land Use Table at § 21-5200 of the LDC is necessary to create consistent language and use of Lodging Establishment as intended; and

WHEREAS, as a result of the changes to other sections of the LDC, it is necessary for City Council to review the changes anew, and on first reading, while providing the residents of Commerce City with additional notice and increased transparency.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

SECTION 1. Findings. The recitals of this ordinance are incorporated as findings of the City Council. This ordinance is found to be necessary for the preservation of the public health, safety, and welfare and in the public interest.

- a) Section 21-5248 Lodging Establishments of the Land Development Code is hereby amended as set forth in Exhibit A to this ordinance, with the specific changes as depicted in Exhibit B to this ordinance.
- b) Section 21-11200 Definitions of the Land Development Code is hereby amended as set forth in Exhibit C to this ordinance, with the specific changes as depicted in Exhibit D to this ordinance.
- c) Sec. 21-5200 Land Use Table of the Land Development Code is hereby amended as set forth in Exhibit E to this ordinance, with the specific changes as depicted in Exhibit F to this ordinance.

SECTION 3. Repealer. All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency.

SECTION 4. Effective Date. This ordinance shall be effective as provided in the City Charter.

- 3) Kitchens Restricted. In-room kitchen facilities shall be allowed only in extended stay or lodging "suite" establishments.
- 4) <u>Guest Services.</u> Lodging establishments shall include typical guest services such as offices, food service, recreation or similar accommodation to support overnight-guests.
