- Circulator of the Survey: There was one circulator for this survey. Prior to the start of the survey, the circulator was briefed on the type of marijuana license and the proposed project, the areas to be surveyed and reminded to be remain unbiased in her approach to residents and businesspeople. The circulator had with her a face sheet with the client's business name, location and City Council hearing information, instructions, and the petition/survey issue along with signature sheets and a map of the proposed location. The circulator used tally sheets to record all contacts, attempts and reasons for opposition signatures and refusals.
