Th City of Commerce City ("City") conducted a public bid opening for the referenced project on February 7, 2019. Two qualified bids were received ranging from \$2,226,359 to \$2,597,720.84. All bids have been reviewed and found to be within reasonable conformance of the Engineer's Estimate. The City recommends the project be awarded to the low bidder, Jalisco International, Inc. in the amount of \$2,226,359.

Attached are copies of the CDOT forms submitted by Jalisco International: 605, 606, 621, 1413, 1414 and 1415. Bid schedules for both bidders are also included.

The enclosed bid tabulation shows the Engineer's Estimate, costs for each bid received, the Base Bid (including Force Account amounts), and Total bid.

The DBE goal was established as 8% and a copy of the Project Special Provision identifying this goal is attached.

The Intergovernmental Agreement between CDOT and Commerce City identifies the maximum federal funds to be used for this project as \$1,541,600.00. The total estimated construction costs are \$2,446,769.00. The City has allocated funds to pay the excess project costs of \$905,169.00. The attached Financial Statement details these costs.
