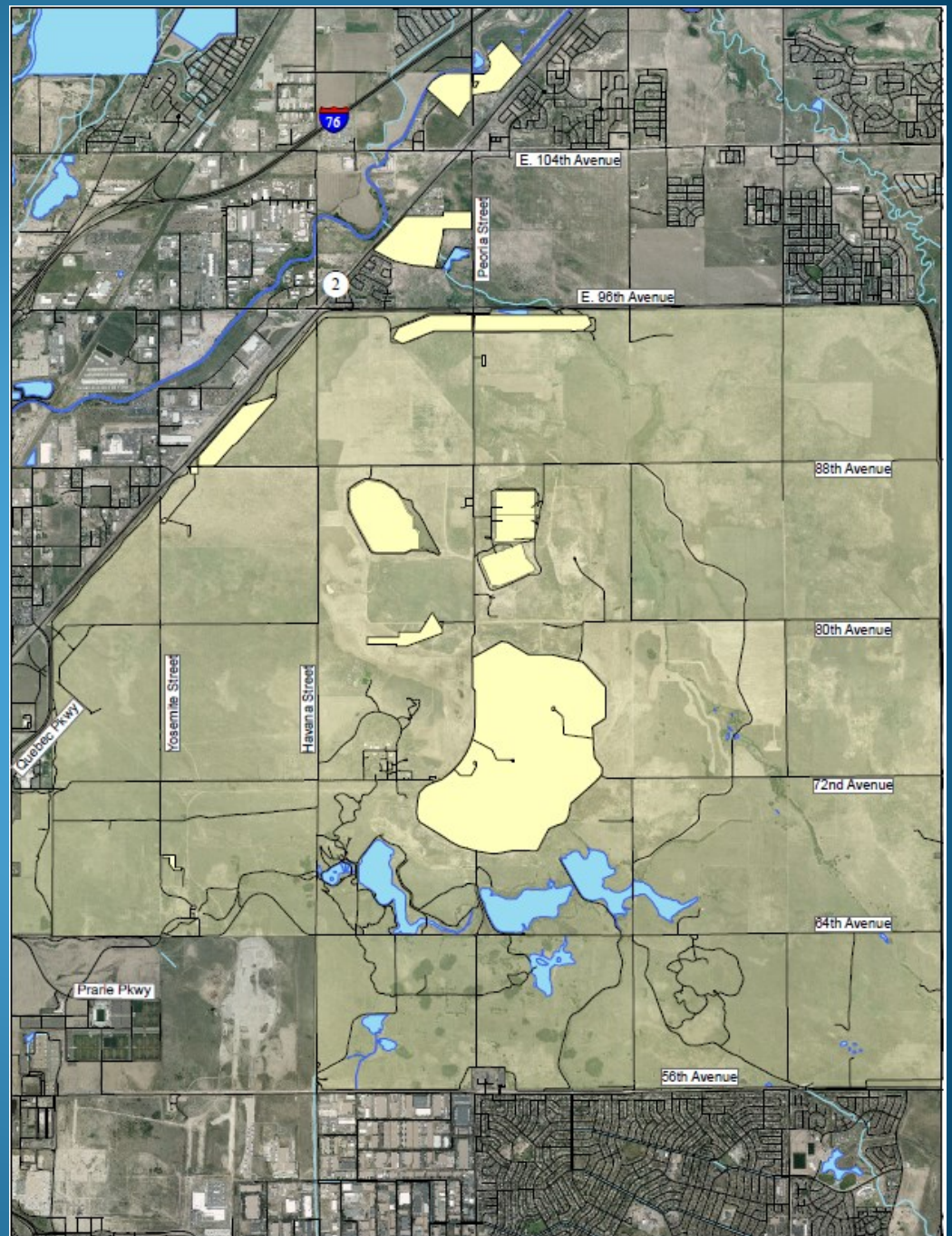

Rocky Mountain Arsenal National Wildlife Refuge and Vicinity



ONGOING OPERATION & MAINTENANCE

- Comprehensive environmental cleanup completed in 2010; long-term operations and maintenance (O & M) of remedy facilities ongoing
- Operation of five groundwater treatment facilities, two landfills, and two engineered soil covers continues to be successful and protective of people and the environment
- Monitoring shows groundwater contamination is being reduced and landfills and soil covers are successfully preventing further groundwater contamination
- O&M done in collaboration with federal, state and local regulatory agencies

ONGOING OPERATION & MAINTENANCE

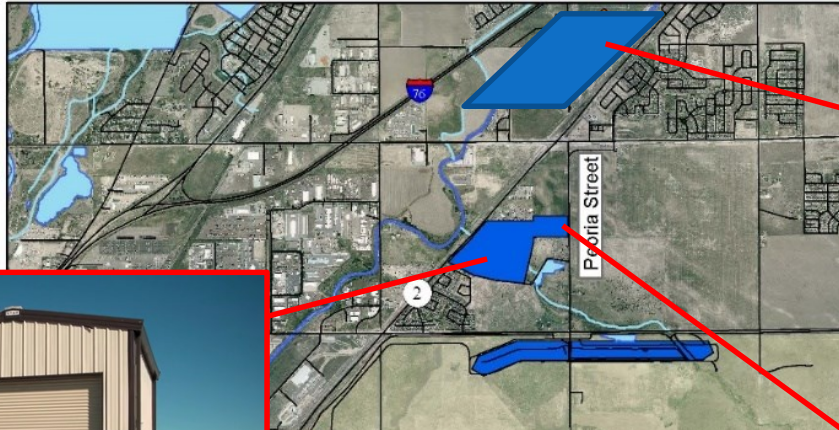
- Over 37 billion gallons of groundwater treated since treatment systems were installed
- Nearly 10,000 lbs. of contaminants removed by groundwater treatment systems
- In 1993, groundwater treatment systems were removing over 650 lbs of contaminants annually
- Due to reduced levels of contamination, groundwater treatment systems now remove approximately 75 lbs. annually

NEW DEVELOPMENTS SINCE LAST UPDATE

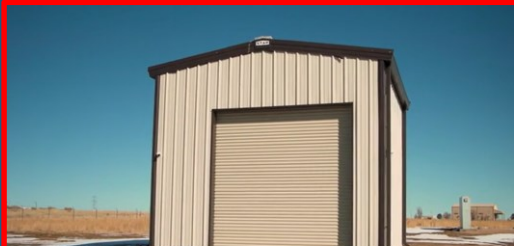
Replacing older treatment systems and reducing offpost footprint:

- Constructed New First Creek Groundwater Treatment System
- Constructed New Northern Pathway Groundwater Treatment System (including new extraction wells and recharge trenches)
- Removed all wells and piping of old Northern Pathway Groundwater Extraction and Recharge System
- Demolished old Offpost Groundwater Intercept and Treatment System

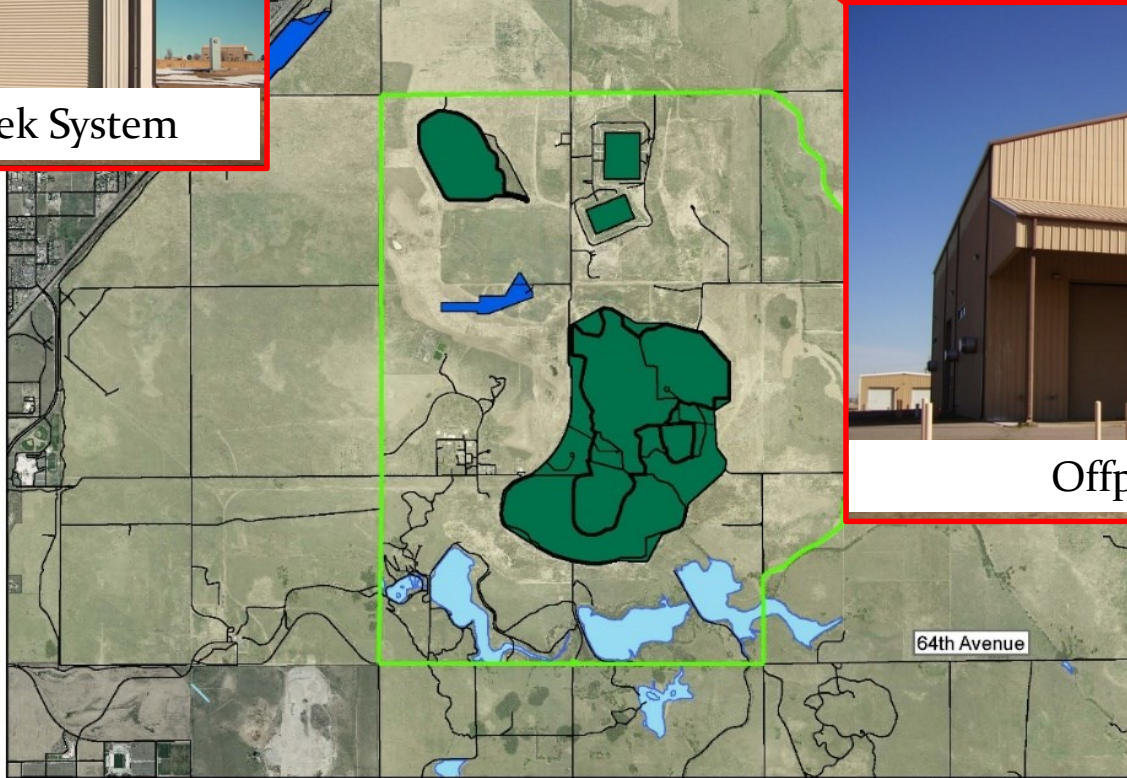
RMA Offpost Groundwater Treatment Systems

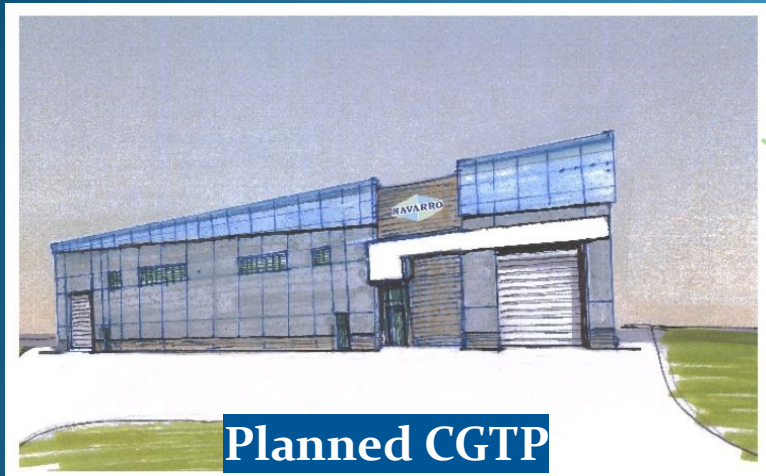
Offpost Groundwater Treatment Plant Demolition



UPCOMING WORK IN 2025-2026

- RMA's Sixth CERCLA Five-Year Review Report will be initiated in 2025; completed in 2026.
- Demolition of a contractor support building will occur in 2025 after staff is consolidated into single Army operations building.
- Construction of new Consolidated Groundwater Treatment Plant will begin in 2026.

CONSOLIDATED GROUNDWATER TREATMENT PLANT (CGTP)



- Consolidates two systems into one; Improves efficiency of existing systems
- Provides capacity to add additional treatment processes, if necessary
- To be constructed 2026-2027



MANAGEMENT TRANSITION

- Charlie Scharmann retiring June 2024
- Recruitment of full-time Program Manager ongoing
- Scott Greene will be Acting Program Manager through September 2024
