Being part of City Council to me means there is a responsibility one has to the citizens of the city when it comes to important and vital issues that will or may affect Commerce City citizens. Secondly, trust because as councilmembers we should be able to trust one another to make the right decision for the people who live in our great city and to ensure we set aside our own agenda or bias as councilmembers and do what is right for the people. The citizens of Commerce City have put forth their trust in each of you to be on council and it is not a responsibility I take for granted or lightly. - 1. Why are you applying to be on the City Council?
- As mentioned in my letter above, I believe that we have a responsibility to the residents of Commerce City to inform and obtain the trust of the residents to ensure City Council is making the right decisions for the residents as they have done in most City Council sessions. I look forward to being part of the solution to help residents understand why certain decisions are made.
- 2. How is your experience and background relevant to being on the City Council?
- I believe my soft skills I have used in previous positions and being fair and balanced has been successful in every position I have worked in. In my current and previous positions, I have worked with several agencies to help build and expand on projects that came to completion. For example, in my current position, we had a backlog of over 10,500 case files that had to be retired to the National Records Center for the U.S. Citizenship and Immigration. In my position, I reached out to several field offices to obtain support, communicated with the Department of Homeland Security, Newark Field Office, Technical Point of Contacts, and Northeast Region government leads and explained how we would ensure the backlog would be handled. After two separate visits, the entire backlog was cleared with the support of 6 staff members (including myself) in physically

completing the work. I see being part of City Council similar to projects like the one explained as I know I would work with City Staff, various agencies, developers, and residents.

3. What are your thoughts on the relationship between the Historic City and the Northern

Range?

- I believe we need to improve upon the relationship between both areas within Commerce City as there is a difference. There is a lot of rich history that I do not believe a lot of residents know or understand how Commerce City came to fruition that started with the Pikes Peak Gold Rush in the 1800s. As the northern range continues to be built out into modern society, I do not believe some residents understand the history of the historic district which is something I'd like for residents across Commerce City to understand.
- 4. What do you believe to be the three most pressing challenges or concerns in the Commerce City community?
- The three most pressing challenges or concerns I believe Commerce City has been 1) Law Enforcement (lack of law enforcement officers, response times, unknown issues with the force), 2) Development (the lack of transparency between developers and residents, amount of funds requested from developers, current and future metro districts and the lack of transparent data that has not been provided, failed promises developers have not lived up to, and accountability), and 3) Education system (lack of teachers which amounts to an increase in student to teacher ratio and the need for a competitive salary for teachers amongst Commerce City and surrounding counties).
- 5. What do you see as the three biggest opportunities for Commerce City right now?
- 1) Development in Commerce City (advising residents on the how the process works, providing tax credits for businesses who wish to open within Commerce City and the need for increased fees for the creation of new homes being developed), 2) Neighborhood Watch Program (building upon the program to neighborhoods to help support local law enforcement in reporting from petty to egregious crimes), and 3) Lack of teachers (bring in competitive salaries comparable to surrounding counties).
- 6. What concerns, if any, do you have about serving on the City Council?
- I do not have any concerns serving on City Council, however, I do understand the importance of this position as it is not just a "title" to have, but actions that matter the most in making it right for many of the residents within Commerce City.
- 7. What does Quality Community for a Lifetime mean to you?
- To me, this is the Commerce City slogan and means we want Commerce City to be a place where residents and businesses want to work and live at by providing quality services. We want the community to feel this is home where we support each other in goals residents want to achieve. Commerce City residents should feel they have the support needed to live in this ever-evolving community.

- Commerce City Veteran's Commission Board, Team Red, White, Blue (Denver and its surrounding counties) Veteran Engagement Director, and Reunion Neighborhood Watch Program
