ORDINANCE NO. 2600

AN ORDINANCE AMENDING THE 2024 BUDGET OF THE CITY OF COMMERCE CITY, COLORADO BY THE RECOGNITION OF COLORADO DEPARTMENT OF TRANSPORTATION FUNDS IN THE AMOUNT OF \$1,420,000 FOR THE REVITALIZING MAIN STREETS PROGRAM AND THE AUTHORIZATION OF THE EXPENDITURE THEREOF.

WHEREAS, the City of Commerce City ("City") was awarded a grant in the amount of \$1,420,000 from the Colorado Department of Transportation ("CDOT") to fund multimodal safety improvements on 68<sup>th</sup> Avenue;

WHEREAS, Resolution No. 2023-030 was passed on April 3, 2023 by the City Council to authorize an Intergovernmental Agreement (IGA) between the City and CDOT regarding the funding for 68<sup>th</sup> Avenue Multimodal Safety Improvements;

WHEREAS, the City and CDOT executed the IGA on March 22, 2024;

WHEREAS, this project will improve safety, multimodal connections, and community access to education and recreational opportunities by adding widened sidewalks on both sides of the roadway, new crosswalks, intersection bulb outs, Rectangular Rapid Flashing Beacons, reconstructed ADA-compliant curb ramps, lane restriping, new street lighting, and drainage improvements;

WHEREAS, this project will improve the safety and comfort of pedestrians and bicyclists going to Alsup Elementary School, and enhance first and last mile connectivity for those going to Commerce City & 72<sup>nd</sup> Avenue Light Rail Station; and

WHEREAS, the City plans to contribute  $$355,\!200$  in funding toward the  $68^{th}$  Avenue multi-modal improvements.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO AS FOLLOWS:

**SECTION 1**. An amendment is made to the 2024 Budget of the City of Commerce City, Colorado for the recognition of the funds from the Colorado Department of Transportation in the amount of \$1,420,000 and the expenditure thereof is hereby authorized (Fund 395).

**SECTION 2**. This ordinance is in the best interests of the City and the general public's health and safety.
