REQUEST

Approve a resolution awarding a construction contract to Lea Park & Play, Inc., d/b/a Recreation Plus, a Texas corporation in the amount of \$339,010.35 for the removal (old playground) and installation of new inclusion playground, as well as ADA surface material at River Run Park.

BACKGROUND

River Run Park was the first city park constructed in the northern part of Commerce City, at 10 acres in size, located at 11515 Oswego St. The River Run Park playground was installed in 2003 and is at the end of its useful life and in need of replacement.

A public outreach process was conducted in Q4 2024/Q1 2025 that consisted of an online survey as well as an in-person outreach meeting held at Thimmig Elementary. A new inclusive playground design was selected through the public outreach process by residents. The playground replacement project was shared with the Parks, Recreation & Golf Advisory Committee (PRGAC) in a CIP presentation on August 20, 2024 and an announcement for the outreach meeting at Thimmig Elementary School was shared at the January 2025 PRGAC meeting.

A Request for Bids for demolition of the old playground, installation of the new playground, and poured-in-place surfacing was released in Q4 2024, Four bids were received with Lea Park & Play, Inc., d/b/a Recreation Plus as the selected contractor to complete the project. Once a Notice to Proceed is issued the contractor will have no more than 140 days to complete the project.

Through the process one design was selected and altered to meet the preferences of the residents.
