2015 AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT CONCERNING THE IMPLEMENTATION OF AN "E911" "EMERGENCY TELEPHONE SERVICE"

This 2015 Amendment to the INTERGOVERNMENTAL AGREEMENT CONCERNING THE IMPLEMENTATION OF AN "E911" "EMERGENCY TELEPHONE SERVICE" is enacted to permit the Adams County E911Emergency Telephone Service Authority to request permission from the Colorado Public Utility Commission to increase the emergency telephone charge from \$0.70 to an amount not to exceed \$1.75. In support hereof, the member agencies of the Authority state:

WHEREAS, the original IGA creating the E911 Emergency Telephone Service Authority was signed in 1986; and,

WHEREAS, the last Amendment to this IGA in 2000 permitted the Authority to implement an emergency telephone charge not to \$0.70; and,

WHEREAS, the Adams County Communication Center has demonstrated a need for funding in excess of the amount that the E911 Authority Board currently raises; and,

WHEREAS, efficient 911 call taking from the citizens of Adams County and the proper dispatching of emergency personnel is paramount to public safety in Adams County; and,

WHEREAS, we support an efficient and effective 911 service in Adams County.

NOW, THEREFORE, the parties agree as follows:

1. That the second sentence in Section V., <u>POWERS OF THE CORPORATION</u>, and the THIRD AMENDMENT shall be deleted in their entirety and replaced with the following:

The Adams County E911 Emergency Telephone Service Authority is authorized as provided by law to impose an emergency telephone charge pursuant to C.R.S. §29-11-102.

EFFECTIVE DATE OF AMENDMENT

2. This Amendment shall be effective upon the execution of this Agreement by a majority of the parties hereto.
