# Purpose of Metro Districts and Service Plans

- Metropolitan districts are government entities created to provide services for an area, typically financing and constructing infrastructure needed for development and operations and maintenance.
- Service plans define and limit district functions, powers, and revenue
- Districts must comply with TABOR, the Colorado Open Records Act and Open Meetings Law as well as Title 32
- District revenue is derived from property taxes and fees, subject to the service plan. District debt is not an obligation of the city and does not impact the city's budget.
- Commerce City uses a model service plan that has been modified to address applicant requests and other updates.


#### Council Action on Service Plans

- City Council action is needed to proceed with formation of districts.
- City Council may approve, approve with conditions, or disapprove of the service plan.
- City Council must disapprove of a service plan unless satisfactory evidence is presented showing:
  - Sufficient existing and projected need for organized service
  - Existing service is inadequate for present and projected needs
  - Proposed district is capable of providing economical and sufficient service
  - Area to be included has or will have financial ability to discharge the proposed indebtedness on a reasonable basis (CRS 32-1-203(2), 204.5)

# Eberly Place Metropolitan District

- Proposed service plan included:
  - Approximately 34 acres for residential uses
  - − Estimated build-out − 385 residents, 2.5 persons per residence
- Estimate improvements cost \$9,700,288.55
- Debt Issuance Limit \$9,700,288.55
- Maximum Combined Mill Levy 60 Mills
  - Maximum Debt Mill Levy 50 Mills
  - − Maximum Operations and Maintenance Mill Levy − 10 Mills
  - Subject to Adjustment with 2022 as base year
- Organizational costs and First year operating budget \$50,000, developer to not receive in excess of \$25,000 in reimbursement for organization
- Applicant's Financial Plan finds sufficient property tax and other revenues to discharge proposes indebtedness.



## **Service Plan Elements**

- Establishes general powers, including constructing improvements (V.A)
- Debt issuance limit based (V.A.15)
- Mill levy caps (with adjustment (VI.C)
- Allows imposition of fees (V.A.16-17)
- Reimbursement agreements cannot include compounding interest; fairness opinion on interest rate (V.A.8, 23)
- Requires City Council approval for modifications, use of eminent domain, and inclusions/exclusions outside of boundaries (V.A.9,11-12)

• Authorizes District Activities IGA (XII)

## **Service Plan Elements**

- Public Benefit (II.C)
  - Contributions towards the completion of Blackhawk Street
  - Financing a regional detention pond
  - Contributions towards offsite traffic signal
  - Provision of road connections for future development sites
  - Regional waterline extension identified by the City as critical public infrastructure

## **Service Plan Elements**

  - Restriction on IGAs with other Entities (V.A.28)
  - 45 Day Notice for Material Modification and petition for Service Plan Amendment (V.A.24)

# **Metro District Review Criteria**

To approve the Service Plan, Council must find:

- A. There is sufficient existing and projected need for organized service in the area to be serviced by the proposed special district.
- B. The existing service in the area to be served by the proposed special district is inadequate for present and projected needs.
- C. The proposed special district is capable of providing economical and sufficient service to the area within its proposed boundaries.
- D. The area to be included in the proposed special district has, or will have, the financial ability to discharge the proposed indebtedness on a reasonable basis



# **Staff Review**

- The proposed service plan appears:
  - To contain the information required by C.R.S. 32-1-202(2); and
  - To support a determination that the requirements of C.R.S. 32-1-203(2) are met, based on the applicant's submissions.
