The applicant for a permit submitted during the six-month period beginning on the effective date of the 2021 edition of the C3BC shall be permitted to choose whether to comply with all of the technical provisions of the 2021 C3BC or the edition in effect immediately prior to the 2021 edition. Applicants for permits designed in accordance with the International Building Code shall be permitted one year after the effective date of the 2021 C3BC to comply with the provisions of this code.*

*Existing buildings and structures shall comply with the provisions of this code related to the City of Commerce City Property Maintenance and Fire Codes on the effective date of the 2021 edition of the C3BC.”*
