to refinance his home. The property was originally platted in 1950 and the home was constructed in 1979. The property was annexed into the city in 1984 and was zoned

C-3 in 1985. Many properties in the surrounding area have been rezoned R-1 to match the residential uses of their property. The planning commission held a public hearing and voted unanimously to forward the case to council with a favorable recommendation.

The applicant could not be present and there was no further testimony.
