PETITION METHODOLOGY

- Survey Dates and Times:

Business & Residential:	Thursday	November 20, 2025	1:30 pm – 3:30 pm
Business & Residential:	Friday	November 21, 2025	1:45 pm – 2:30 pm

- Survey Areas: Circulators started in areas closest to the proposed licensed site and obtained complete coverage of the boundary area. Multiple attempts were also attempted at those businesses and residents that were not available on the first survey day. Please see attached map.
- Circulators of the Survey: There was one circulator for this survey. Prior to the start of the survey, the circulator was briefed on the type of liquor license application, the areas to be surveyed and reminded to remain unbiased in their approach to businesspeople. The circulator had with them a City approved petition/survey packet, along with a map of the proposed location. The circulator recorded all contacts, attempts and reasons for opposition signatures and refusals. At the conclusion of the survey, the circulator signed a notarized affidavit of circulation. The original survey packet was pre-filed with the City Clerk's Office.

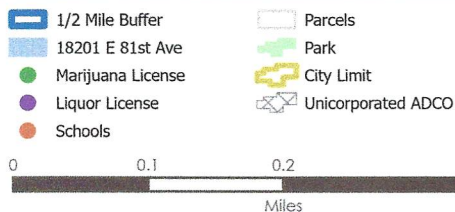
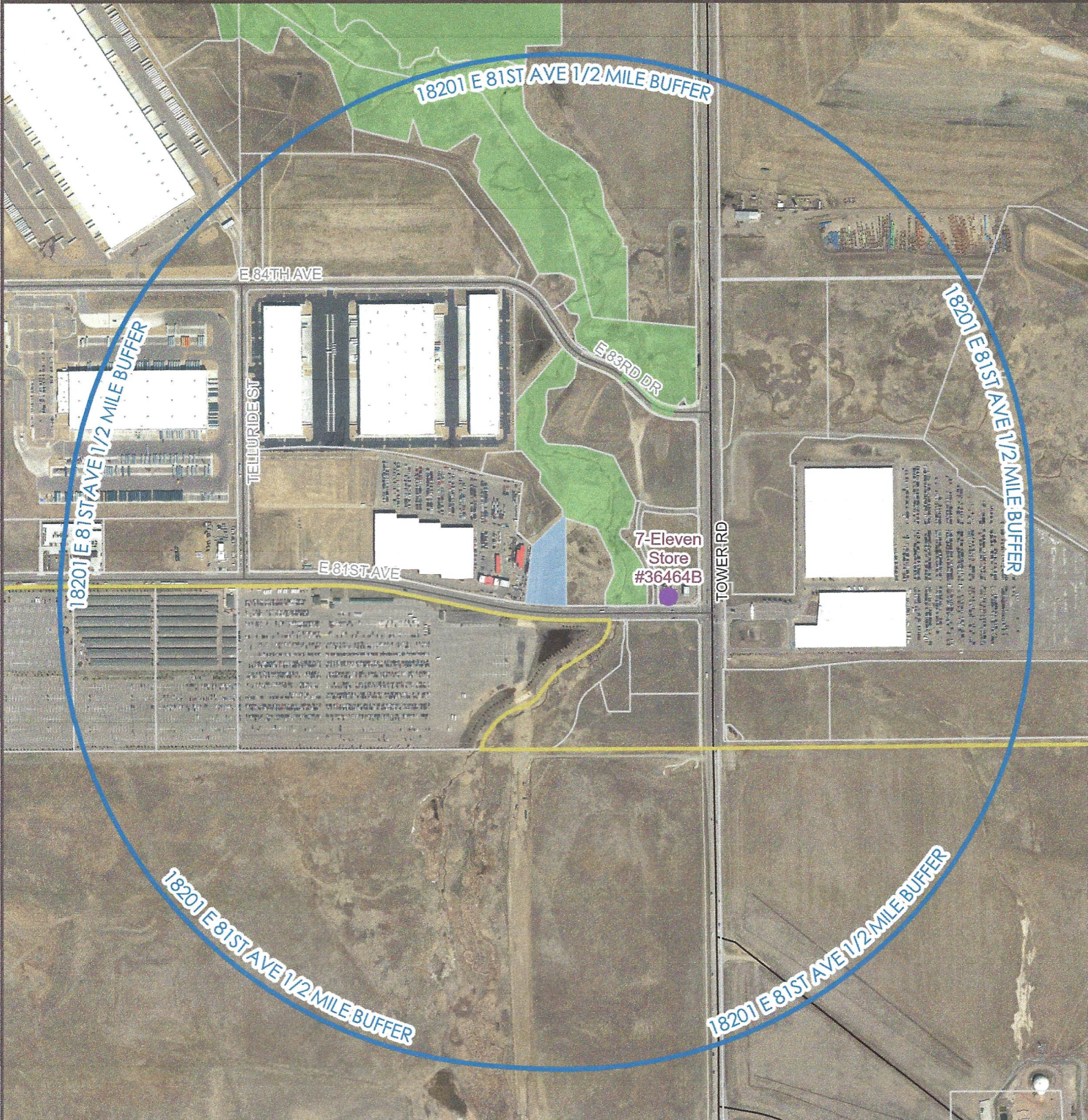

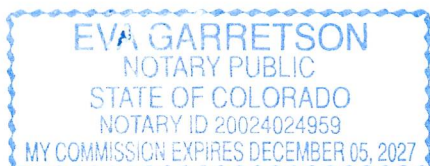
