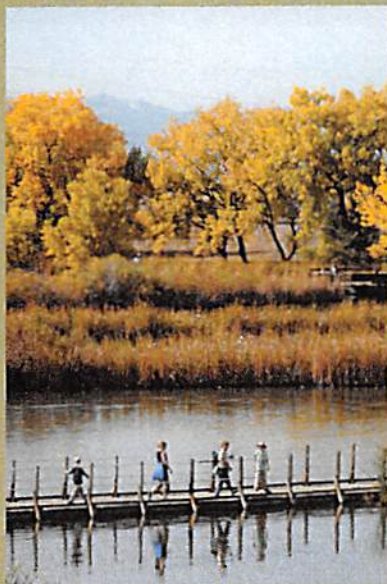
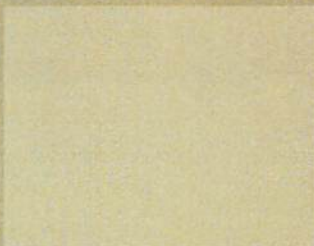

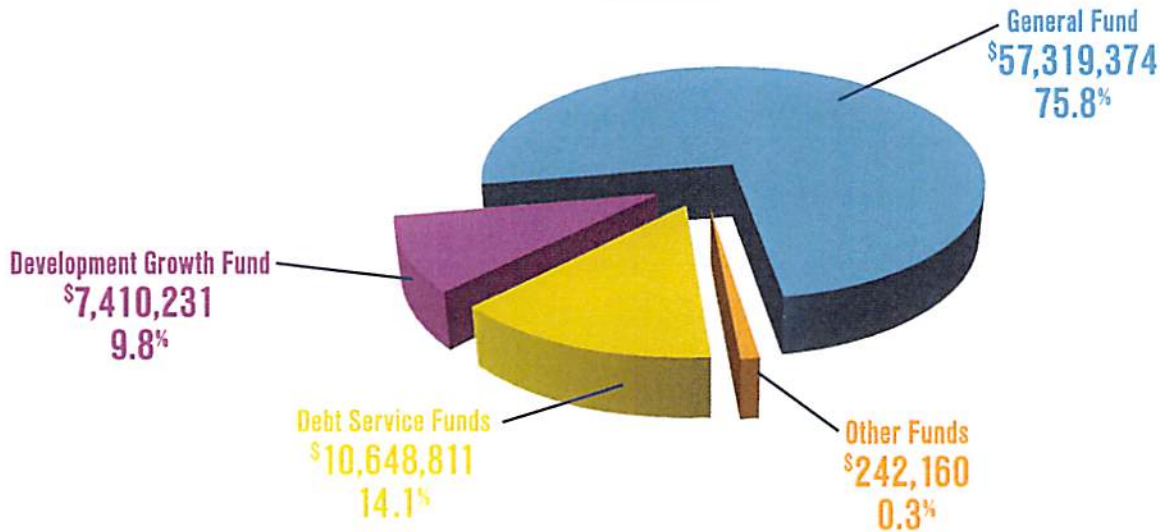
Revenues and Expenditures

General Fund

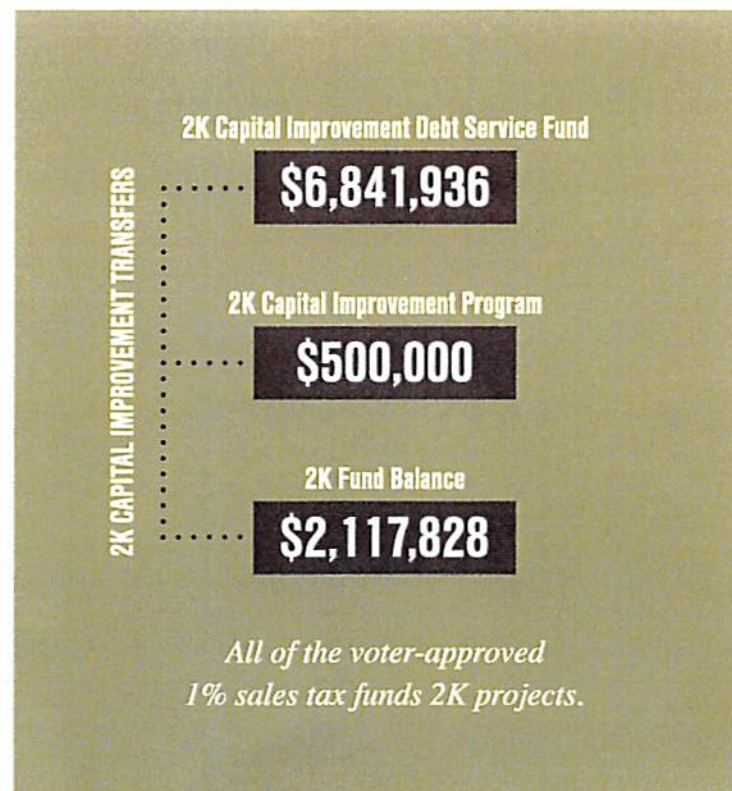
- The General Fund is the city's primary operating fund and funds day-to-day service operations.
- 2017 budget for revenues is \$71,808,912.
- This includes money allocated for the 2K Capital Improvement Projects

Sales and Use Taxes

The city's current sales tax rate is 9.25%.
This is how it is distributed:

Commerce City.....	4.5%
State of Colorado.....	2.9%
Adams County.....	.75%
RTD.....	1.0%
Cultural and Scientific Facilities District.....	1%



2017 Budget Transfers

\$57,319,374 will remain in the fund to support the core services the city provides. Since revenues and expenditures need to be balanced, money from the General Fund is transferred to other funds.

- 8 full-time employees
- Administration, risk management, and organizational development

Facility Services..... \$1,973,820

- 4 full-time employees

- 40 full-time employees
- Administration, street and traffic maintenance, snow and ice control, street cleaning, engineering, refuse collection

- 54 full-time employees
- Administration, parks maintenance, parks maintenance – 2k parks, recreation programs, outdoor leisure pool (2k), community events, golf course maintenance, golf course operations, golf course restaurant

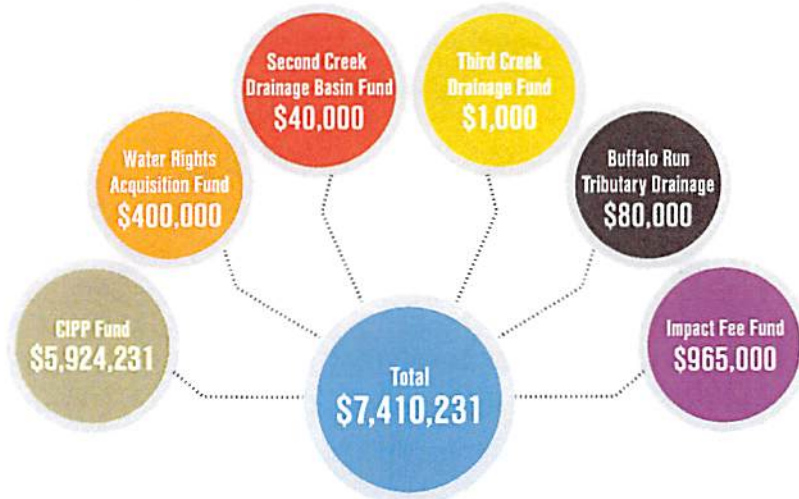

Developmental Growth Funds

- Developmental growth funds pay for the acquisition and construction of projects that will add value in the city, such as Paradise Island, Pioneer Park and Buffalo Run Golf Course.
- Drainage funds collect fees for homes built within the drainage basin. These funds may be used only for drainage improvements within the drainage basin.
- The Capital Improvements and Preservation Plan fund is used to fund capital improvement projects throughout the city. These projects include Tower Road expansion and the building of the new recreation center.
- Impact fees are collected when issuing permits. The fees collected are required to be used for specific projects based on the type of fee that is collected.

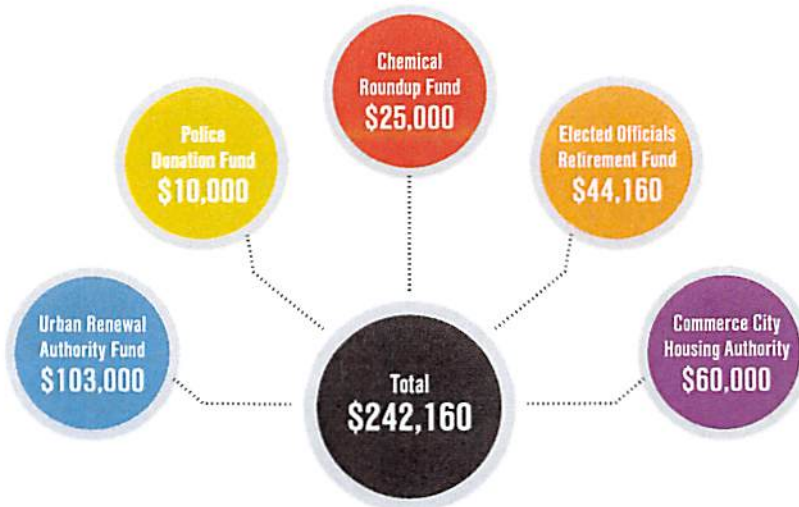


Debt Service Fund

- This fund accounts for the accumulation of resources and the payment of general long-term debt, including principal and interest.
- The total sources and uses are \$10,648,811.

Other Funds

- Budgeted dollars are used for specific projects withing each fund. For example, the Chemical Round Up Fund pays for the management of household hazardous waste in the city.
