

**A RESOLUTION FOR THE ACCEPTANCE OF A PUBLIC ART DONATION  
AND INSTALLATION OF SUCH PUBLIC ART AT EAGLE POINTE  
RECREATION CENTER**

WHEREAS, on March 4, 2013, the City Council approved a Public Art Master Plan (the Plan”) to implement a public art program for the City of Commerce City (the “City”);

WHEREAS, the City’s public art program is administered by the City of Commerce City Cultural Council (the “Cultural Council”);

WHEREAS, the Plan identifies a process for reviewing, accepting, and placing donations of artwork in spaces accessible to the public;

WHEREAS, Sand Creek Regional Greenway Partnership, Inc., a Colorado non-profit corporation, has offered to donate a piece of artwork titled “Protecting Commerce” (the “Artwork”);

WHEREAS, a selection committee was assembled by Sand Creek Regional Greenway Partnership, Inc. and approved by the Cultural Council, and the selection committee has recommended that the City accept the donation of the Artwork and place the Artwork in the Eagle Pointe Recreation Center;

WHEREAS, on February 18, 2025, the Cultural Council unanimously supported the selection commission’s recommendation that the City accept the Artwork and place the Artwork in the Eagle Pointe Recreation Center;

WHEREAS, pursuant to the Plan, the Cultural Council presents its recommendation that City Council approve the donation of the artwork and placement in Eagle Pointe Recreation Center;

WHEREAS, Section 4.18 of the Charter for the City, titled *Bequests, gifts and donations*, authorizes the City Council to receive bequests, gifts, and donations of all kinds of property for public or charitable purposes, and to do all things and acts necessary to carry out the purposes of such gifts, bequests and donations.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

**SECTION 1.** The City Council accepts the recommendation of the Cultural Council to accept the donation of the Artwork from Sand Creek Regional Greenway Partnership, Inc. and place the Artwork in the Eagle Point Recreation Center.

**SECTION 2.** The City Council hereby accepts the donation of the artwork titled “Protecting Commerce” from Sand Creek Regional Greenway Partnership, Inc. and approves the Artwork Donation Agreement in substantially the same form as attached hereto as Exhibit A, which sets forth the terms of the donation to the City. Upon successful finalization of the contract

and approval as to form by the City Attorney, the City Manager or the City Manager's designee is hereby authorized to execute, and the City Clerk to attest, the contract on behalf of the City.

**SECTION 3.** The City Council directs City staff to take all steps necessary to effectuate the donation and carry out the purpose of such donation.
