REQUEST

Approve an ordinance amending the Commerce City Revised Municipal Code (CCRMC) to codify a Code of Ethics.

BACKGROUND

City Council has identified the need for the City to codify an ethics code that would be applicable to all City officers, officials, and employees. Currently, portions of ethics requirements reside in multiple locations of the City Charter, CCRMC, and Council Policy. On January 27, 2025, the City Council received a presentation on a draft centralized ethics code by the City Attorney's Office. Following the presentation, City Council directed the City Attorney to draft an ethics code.

If this ordinance is adopted after second and final reading, future resolutions will be scheduled for adoption by City Council to repeal Council Policy 14.
