National Community Survey launching soon

Staff is working with a polling consultant to launch the city's participation in the National Community Survey for 2023, renewing a project the city previously participated in from 2017 to 2019. The NCS questionnaire provides a comprehensive picture of resident perspectives on community livability. Staff will use the quantitative results from the NCS as the basis for further qualitative conversations with residents and community members. Approximately 3,000 residents will be selected at random, but equally distributed by ward boundaries, and given six weeks to complete and return the survey. Four weeks into this period, the survey will open up to the general public. Residents will start receiving mailed postcards and letters inviting them to participate in the survey within the next few weeks.

Business/Economic Development



Business Attraction

- Staff reached out to a local restaurant concept to request an introduction to their real estate representative to learn more about their expansion plans and real estate requirements for new store locations. Staff is also confirming their preference for owning real estate versus leasing opportunities. The concept currently offers breakfast, lunch, and dinner in a traditional setting.
- Staff is assisting the development team of a general merchandise store planned for E. 104th Ave. to get their plans finalized with the South Adams County Water and Sanitation District (SACWSD). Staff is currently coordinating outreach to SACWSD to schedule the preconstruction meeting with the project team.
- Staff received an update from the District Manager for the auto parts retailer on the new store location being developed along E. 104th Ave. Staff confirmed that they are finalizing the installation of security and fire monitoring systems. They are currently targeting a soft opening in early January 2024.

Business Attraction – Continued

- Staff received an update on a planned PUD amendment for a commercial development site along E. 104th Avenue & Tower Road. Staff confirmed that two commercial buildings are proposed including a 2,500+ square foot space targeted for restaurant use.
- Staff reached out to the General Manager of a building materials manufacturer to request an update on their operations and discuss possible investment in capital equipment. Staff plans to identify and confirm how the City could support their potential expansion.
- Staff was made aware an existing Commerce City company has leased over 60,000 square feet in the Park 76 distribution center to accommodate their business growth. The expansion includes a \$500,000 investment in the new warehousing & distribution facility and will add 10-15 new jobs in the community. Staff is assisting them with the permitting process.

Business Retention & Expansion

- Staff was contacted by two business owners in the Derby area that are seeking relocation assistance. The business owners were recently notified by the landlord they will need to relocate by mid-December. The property owner plans to renovate and sell the building.
- Staff met with the Energy, Equity and Environmental Division to learn more about Colorado's Green Business Network. The program is dedicated to creating partnerships among businesses, governments and organizations. The goal of the program is to foster good relationships; reward environmental performance and create a healthier, cleaner and more sustainable Colorado. Staff also learned about the Small Business Equity Fund Pilot Program that is designed to provide funding to small businesses interested in replacing their old kitchen refrigeration equipment with energy efficient models. Staff will promote these opportunities to increase education and awareness, and incorporate them into business retention site visits.

Infrastructure

PW Updates

- Public Works staff responded to the first snow event of the year. Approximately 4-5 inches of snow fell around the City. Over 55 tons of material was placed on the roads to address slick areas and promote melting of the snow. In total, plow operators logged approximately 1,700 miles of driving and the roads were cleared by late Sunday afternoon.
- Prescribed burning is planned at the Rocky Mountain Arsenal National Wildlife Refuge on November 6. The burns will be conducted between 9 a.m. and 4 p.m. Smoke will be visible for several miles from the perimeter of the Refuge and people in the area may smell smoke. - The Colorado Department of Transportation (CDOT) removed graffiti from the N-line bridge over I-270.

Engineering

- A kick-off meeting was held with staff from the Mile High Flood District to begin studying options for detention in the Irondale Drainage Basin.
- CDOT held a quarterly meeting with agencies located in Adams County to provide updates on CDOT projects.

Parks

- Staff removed debris along the Sand Creek Trail.

- Staff completed top dressing the ballfields at Pioneer Park.
- Staff completed moving operations in City parks and along the trails and open space areas.

Streets

- Routine daily operations include pavement/road maintenance (pothole patching shoulder maintenance, grading, etc.), street sweeping, rightof-way mowing, weed control, traffic sign maintenance and replacements, clean-up of illegal dumping, and responding to SeeClickFix reports on a wide variety of issues.
- Prior to the snow event this past weekend, mowing operations continued on E. 96th Avenue and Highway 2.
- There were no new MyC3 trailer rentals.

Facilities

- Routine daily operations include maintenance and repair of all City facilities.
- Staff has been working on SeeClickFix tickets assigned to the Facilities Team.
- Winterization operations at Paradice Island is complete.
- Staff is addressing issues with the heating system at the Civic Center.

Fleet

 Staff worked on snow plow trucks readying the plows and sanders for the first snow of the season.

Parks, Recreation and Golf

Monaco Park Renovation Beginning

Monaco Park is approximately 9 acres and located at 5790 Monaco Street. The current renovation includes the following:

- New park shelters, rentable for residents
- New inclusive playground
- ADA accessible features including sidewalk connections inside the park and to the new parking lot
- New pedestrian level lighting
- · Play amenities in the southern-end of the park
- New fitness court
- Flush restroom

Renovation construction began October 2023 and is anticipated to be completed May 2024, weather dependent.
