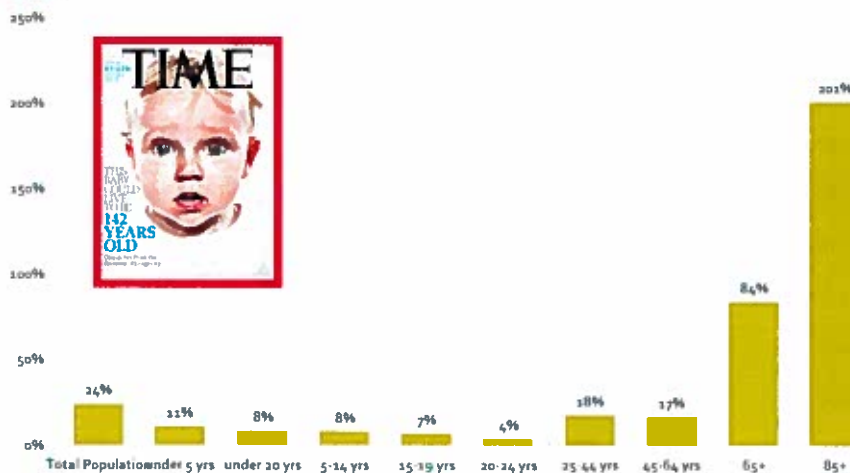

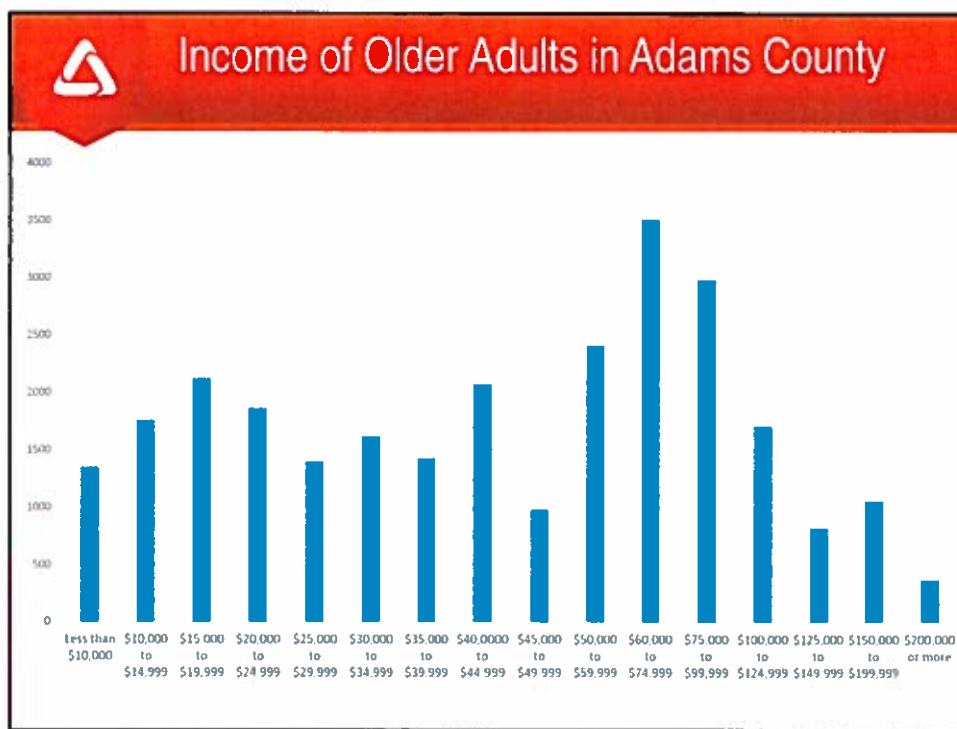
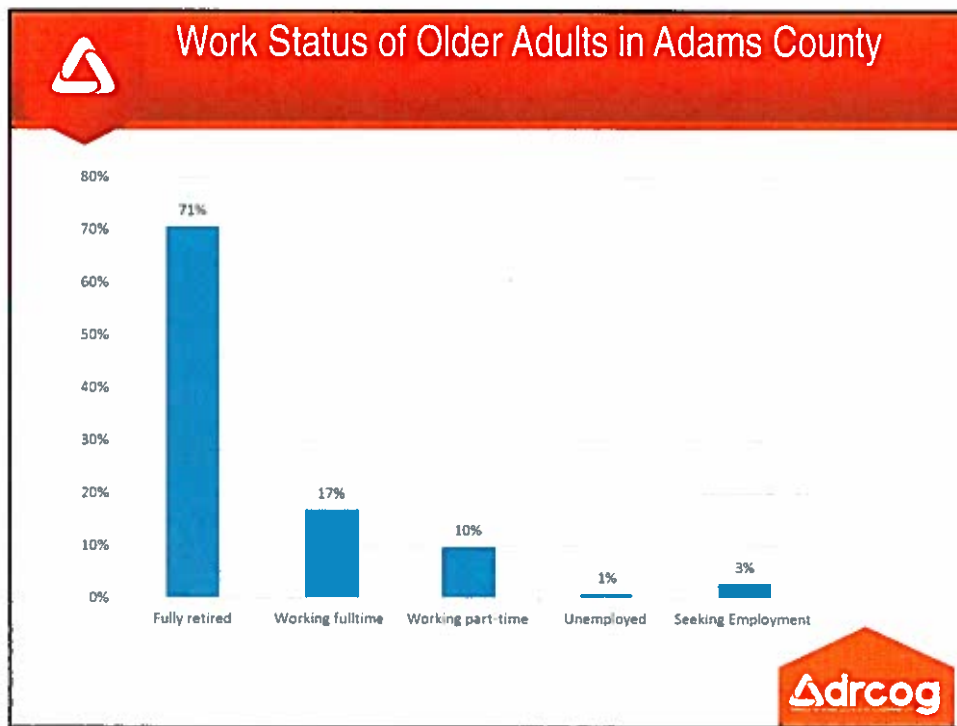
Projected rates of growth by age group: 2015 to 2050

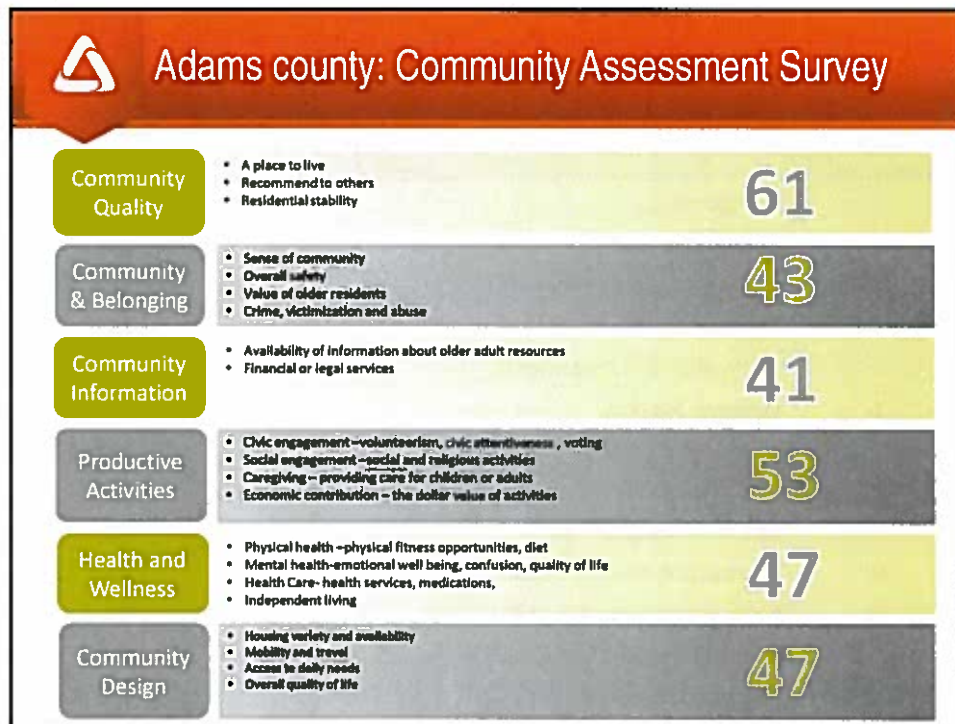

WHY GET INVOLVED THE OLDER AMERICANS ACT

- 1

You love your grandparents.

The Older Americans Act supports more than 11 million older adults each year by providing a wide range of services, including: transportation services, nutrition assistance, support and respite for family caregivers, protection against elder abuse, and job training for seniors.


- 2

You care about social justice.

The Older Americans Act protects seniors from financial fraud, physical abuse, and abuse in long-term care facilities, like nursing homes, through the Long-Term Care Ombudsman and other programs. Other programs in the OAA, like home delivered meals, family caregiver supports, and community service opportunities, go first to lower income families and families with the greatest need.

You want to help families and lower health care costs.

By supporting home- and community-based services and family caregivers, the OAA helps many older adults avoid costly institutional settings that can drive up health care costs. This can help people live their golden years and parents to age with dignity and independence in their homes and communities.

Seniors in Adams County

What is being worked on?

- Poverty Reduction Taskforce was established to look at specific groups of people and geographic areas in the county. Dozens of agencies have been involved. “Seniors” were a specific group that was targeted.
 - Seniors Poverty Reduction group focused on three key areas:
 - Affordable Housing for Low to Moderate income seniors
 - Affordable and appropriate Transportation options
 - Ease of access to Public assistance programs and community resources
- Community Enrichment Facebook Page
 - Established to give a portal to county, municipality and non-profit providers a place to share resources, fairs and other events aimed at helping county citizens.
- Mapping of multiple demographics in the county
 - Data was gathered to show numerous factors involved in poverty including:
 - Transportation (where people come and go from)
 - Neighborhoods with high levels of poverty
 - How to target outreach
