AN ORDINANCE AMENDING THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF COMMERCE CITY, COLORADO FOR REZONING TO PUD ZONE DISTRICT AND APPROVING A PUD ZONE DOCUMENT FOR THE PROPERTIES DESCRIBED IN EXHIBIT "A" ATTACHED HERETO AND MADE A PART HEREOF COMMONLY KNOWN AS PARCELS 172300000075 (GENERALLY LOCATED SOUTH OF EAST 104TH AVENUE, BETWEEN POTOMAC STREET AND CHAMBERS ROAD) AND 172300000272 (GENERALLY LOCATED SOUTH OF 104TH AVENUE AND EAST OF HIMALAYA STREET), COMMERCE CITY, COLORADO.

SECTION 1. - **SECTION 2.** The City Council of the City of Commerce City, Colorado further finds and declares that it has caused to be published in the Denver Post, a legal newspaper of general circulation in the City of Commerce City, Notice of Public Hearing held on June 2, 2014 regarding zoning of land hereinafter described, and said Notice was published on May 25, 2014, and said hearing was conducted all in compliance with law.
- **SECTION 3.** That the property described in Exhibit "A" attached hereto and made a part hereof, now zoned Commerce City AG and Adams County AG be rezoned Commerce City PUD as defined in the Commerce City Zoning Ordinance and the PUD Zone Document is approved.
- **SECTION 4.** That the zoning map of the City of Commerce City, Colorado be and is hereby amended to reflect the zoning amendment as provided in this ordinance.
- **SECTION 5.** That the rezoning is approved from Commerce City AG and Adams County AG to Commerce City PUD and the PUD Zone Document is approved.
