Staff estimates close to 300 community members attended the city's Hispanic Heritage Month celebration Saturday afternoon in Downtown Derby. The event was a partnership with Cultivando, the Cultural Council, and local Derby businesses to celebrate our community's rich Hispanic culture. It featured multiple music and dance performances, crafts and kids' activities, discounts at local restaurants and shops, and informational booths. The city would like to thank all the partners, businesses, volunteers and attendees for helping to start a new cultural event in our community!

#### **Business Attraction**

 Staff reached out to a Chicago-based hospitality group that operates 15-plus brewpub restaurant concepts to request a meeting to discuss possibility of a location in Commerce City.

 Staff received an update from a broker for a regional pizza tap house restaurant concept on their real estate requirements and discussed their potential interest in the site at 120th & Chambers.

- Staff reached out to the developer of a project near 104th & E-470 to schedule a meeting about potential anchor tenants for the commercial portion of the first phase of their multi-use project.

- Staff represented and promoted 10 large scale development sites in Commerce City in the Tower Road corridor as part of the Adams County Regional Economic Partnership (AC-REP) Regional Bus Tour.

- Staff requested meeting with a California burger restaurant concept to discuss their Colorado expansion plans and real estate requirements. Their real estate director confirmed that any sites to be considered should be submitted to their local commercial brokers.

#### **Business Attraction – Continued**

– Staff met with the Vice President of Business Development for an indoor adventure park concept to discuss and propose potential corporate location sites along Tower Road. Staff learned that they require a 35,000 square foot building with ceiling heights of at least 22 feet.

 Staff conducted a real estate property search for a health and wellness business that is considering a location in Commerce City. Staff provided several options for them to consider, ranging from 850 to 2,500 square feet.

– Staff connected a retail food business with funding resources to complete an expansion of menu items.

 Staff connected with a local property owner to discuss potential businesses that could be operated from a recently acquired vacant property in the Derby area.

- Staff is working with the Aerotropolis consortium on preparing the launch of a website, presentation deck, and other marketing efforts for the region. The group is exploring a launch event timeframe around the first or second quarter of 2024.

 Staff met with a business owner in Derby to discuss requirements for obtaining an Outdoor Service Area Permit to expand the service area at their restaurant.

 Staff started planning a groundbreaking ceremony for a hotel at 96th & Tower. The team is working on confirming logistics, guest list and other aspects of the event.

- Staff is participating in the Metro Denver Economic Development Corporation (MDEDC) Site Selection event this week. Six site selectors will be hosted at this year's event representing industry segments from food and consumer products, incentive experts, and Fortune 100 companies. The week wraps up with a "Site Selector Feedback Breakfast" where they will share their observations of metro Denver.

#### **PW Updates**

Public Works staff evaluated conditions and performed various maintenance activities to prepare for the Hispanic Heritage Month celebration in Derby. Staff executed street closures and remained on site to provide support in addition to operating an outreach booth showcasing the MyC3 Tool Trailer and the exciting program opportunities.

The Colorado Department of Transportation's I-270 Bridge Repair Project began over the Sept. 29 weekend.

Various projects are out to bid or going out to bid soon, including:

- Long Lane and Pavement Marking Program. Bid proposals are due Oct. 12. Work is planned to be completed this fall/early winter.
- Roadway Crack Repair Program. Bid proposals were due Oct. 3. Work is planned to be completed this fall.
- Safe Streets for All (SS4A) Safety Action Plan. Bid proposals are due Oct. 19, with selection occurring in November with work to begin on the Plan in December.

#### Engineering

- Staff is working with Police Department personnel to evaluate optimum locations for the Flock cameras.

#### What is Urban Renewal?

Urban Renewal is the action of revitalizing a struggling area in order to restore economic vitality and improve safety. Recognizing that redeveloping urban areas is much harder and more expensive than new development, in 1958 the Colorado General Assembly empowered municipalities with specialized tools to facilitate private investment.

#### Who is the Urban Renewal Authority?

Established in 1978, the Commerce City Urban Renewal Authority (CCURA) is responsible for improving "blighted" areas within the city. The 13-member Board of Commissioners consists of the Commerce City Mayor and City Council; a member of the Adams County Board of County Commissioners; a special district board member; a member of the Adams 14 Board of Education; and an at-large member appointed by the Mayor.

#### Why is Urban Renewal Important?

Urban Renewal is important to the success of Commerce City and the long-term prosperity of its citizens. Without urban renewal, developers often lack the support and incentive to tackle the challenges associated with complicated redevelopment projects. In turn, blighted areas often experience increased crime and safety problems. Because of urban renewal, the CCURA has been able to actively participate in private sector revitalization efforts and make significant improvements to communities in Commerce City.
