#### To Whom It May Concern:

I want to bring awareness to the constant accidents on the stretch of Highway 85 between 104<sup>th</sup> Avenue and c-470.

I've been a homeowner in the River Oaks neighborhood since 2014 and have witnessed numerous automotive accidents along this stretch of highway 85, more recently with the 4 young lives lost due to somebody running a red light at Highway 85 and 112<sup>th</sup> avenue. Not but a week later, another accident happened at that very intersection. Thankfully nobody was hurt. . . that time. I also personally know somebody that died at that intersection more than 10 years ago. I don't know what the solution is, but it's a serious issue and with all the new development and housing in the area and this stretch being one of the very few ways out of the city, it needs to be finally addressed.

Can we set up red light cameras? More policing? Lower the speed limit until you get out into Brighton? I'm not sure. Whose life needs to be taken too soon before somebody does something about it?

In conjunction with the above, I wanted to raise the issue of the trains blocking the intersections at 104<sup>th</sup>, 112<sup>th</sup>, and 120<sup>th</sup>. There was a train blocking the intersection the night that those 4 teenagers lost their lives at the intersection of Highway 85 and 112<sup>th</sup> Avenue. Could they have been saved if the fire fighters from the South Adams County Fire Station Number 7 were able to reach them sooner? According to *Google*, the fire house is a 1-minute drive (.7 miles away) or if the train is blocking the intersection 7 minutes (3.2 miles) if they have to turn north bound on Havana.

Through it all, a huge group of educators remains committed to this community and our students' success because we believe in them and we have seen MANY students accomplish great things despite the difficult obstacles many have had to overcome.

I am writing to you to ask you to support us in fighting for local control of our community. To fight for keeping this district intact so our students are able to stay together and not be torn from each other because that is exactly what will happen if the district is reorganized or the students attending the high school have to go to different high schools in surrounding districts.

I believe it would be a huge mistake to disband the district or turn it into charter schools. The Adams 14 Community and students are a very unique group of people. The leaders, faculty, and support staff have spent years developing strong relationships and committing to this community. No other school system understands them as we do. In my opinion, this would be the worst outcome that could happen because it would not give them the quality and equitable education that the State is seeking, it would set these students back for years to come because if they were absorbed into new schools, I fear many would simply "fly under the radar" and it would likely take years before a new teacher or system could determine their needs if ever.

I realize that they are following the letter of the law, but as a member of the City Council, I am hoping you can suggest that they fight to do away with the ridiculous law of having a test score define a student and school's worth.

Hi. My name is Mona Gabaldon, I'm a parent of a student at ACHS and a teacher in the district. I'm writing to express my concern and voice for the future of our schools. First of all, my daughter is a sophomore at ACHS and because of all the uncertainties right now, we are both feeling very concerned. First of all, as I have expressed many times this year to MGT and other district leaders... our kids (my daughter) deserve to have a good education, an education that is uninterrupted and secure.. our kids have hopes and dreams and want to graduate!!! My daughter is aware of all the challenges and uncertainties our district faces and we are directly affected with these uncertainties as her school ACHS and my school Central Elementary have been under the stress of many opinions, changes and judgements. Despite all of this, my daughter does not want her school to shut down. She loves her school and has adjusted well to ACHS... she is a student with high honors, a GT student and very motivated. She is proud of her school, has good relationships with adults, and is comfortable to speak to the principal about any concerns she has about her studies or safety. ACHS also needs Mr. Garcia. He has provided and followed through with three very important factors to students and parents this year. One, stability... our kids need structure, consistency, and stability! They need to know their principal and teachers care about them enough and believe in them.... to come back to ACHS. Mr. Garcia has shown he cares about the students at ACHS and has expressed a desire to come back to ACHS next year. Next, his relationships with students and parents have made us feel welcomed, supported and heard. He is approachable and has good relationships with students. My daughter "likes" him and feels that he cares about the students at ACHS. For example, he gets involved by covering classes for teachers and going out of his way to check in with students that may need support. Finally, he is committed to his position as principal of ACHS, to Adams 14, and most importantly to our students.

I have taught at Central for 8 years and I am very dedicated to my school, the students, and to the district. I have also expressed my concern about Central to every person I could who came in to gather data on the school. One of my biggest concerns about Central is the extreme social/emotional behaviors we have at our school. Our students are highly impacted by poverty and I strongly believe this has an impact on student achievement. For example, my students come to class often tired, hungry, emotionally distraught or a combination of them all. I also feel very offended about some of the opinions that have been formed and shared about our school. It is very hard to listen to business people/politicians share opinions and judgements about our school and our students. We have struggled with student achievement but we have also worked every minute everyday to do our best for our students too. The staff at Central has been together for many years and we have not chosen to "leave" Central in the mess it's in, like so many of our previous principals and administrators have... Central has struggled through so many changes at the district level with management and with our own management in the building. All those inconsistencies have also impacted Central in a negative/stressful way. Without systems and leaders in place, it is VERY difficult for a struggling school "to get back on it's feet." Therefore, all the scrutiny we have faced over the years has made us more resilient and more committed to our students at Central. Furthermore, not only have most of our staff stayed around to support our school, but our students and our families LOVE Central, that is our school and their support for many needs they face as community members of Central. Families rely on us daily to help them and kids look forward to seeing us because they know WE truly care about them and we will do anything to help our students and our families. Central is a place where families find comfort and love and they need us, like we need them..... I hope you will consider all these factors and so much more when deciding the fate and future of our students, because again our kids deserve the
