Mayor Ford opened the public hearing for the following items:

City Attorney Sheesley swore in Planning Manager Steve Timms who testified to the following findings:

City Council adopted a plan for the area,

At least one-sixth of the area proposed to be annexed is contiguous with the existing boundaries of the city,

A community of interest exists between the area proposed to be annexed and the city,

The area proposed to be annexed is urbanized or will be urbanized in the near future, The area proposed to be annexed is integrated or is capable of being integrated with the city.

All the land owners signed the annexation petition,

No annexation proceedings have been effectively commenced for the annexation to another municipality,

The proposed annexation will not result in the detachment of area from any school district and attachment of the same to another school district,

The proposed annexation will not have the effect of extending a municipal boundary more than three miles in any direction from any point of the city boundary in any one year, The entire width of any street or alley to be annexed is included within the annexation.

Mr. Timms presented the case. He stated that the applicant, Mid Rail Real Estate is seeking to annex, vacate, and rezone property located in the vicinity of 84th Avenue and Ulster that includes approximately 54 acres of various zoning designations. Future development includes a rail spur.

Sam Stein came forward on behalf of the applicant.

No one came forward to speak in favor or opposition to the proposals, and the public hearing was closed.
