# New & Notable

## **E. 104th Avenue closed east of Highway 85 for rail repairs**

E. 104th Avenue is closed in both directions just east of Highway 85 through Sunday as the Union Pacific Railroad completes repairs to the rail crossing, which will also improve driving conditions for motorists. The closure began after the morning commute on Thursday and is expected to remain in place through most of the day on Sunday, April 7 before reopening (construction schedules are tentative and subject to change). Suggested alternate routes between Highway 85 and Highway 2 include E. 96<sup>th</sup> Avenue to the south and E. 120<sup>th</sup> Avenue to the north.

The city partners with railroad companies BNSF and Union Pacific on an annual basis to evaluate the conditions of railroad crossings in the city and determine a repair schedule for the upcoming year. ## **Neighborhood Meeting coming April 11 for E. 62nd Avenue & Holly Street improvements**

Public Works staff is hosting a neighborhood meeting to share information with community members about the upcoming project to improve the intersection of E. 62nd Avenue and Holly Street. This project will improve safety and efficiency for motorists, bicyclists, and pedestrians while improving roadway conditions. The meeting will be held on Thursday, April 11 from 6 to 7:30 p.m. at the Suncor Boys & Girls Club, 6201 Holly St.

## **CDBG Public Input Meeting – April 17**

The city's Community Development Block Grant (CDBG) program is hosting a public input meeting to collect resident feedback on proposed community projects that could be selected for funding with federal grant dollars. Each year, this feedback helps the city select projects that have public support while meeting federal requirements for assisting low to moderate-income residents and neighborhoods. # Business/Economic Development



- Staff partnered with the Community Relations team to launch monthly coordination meetings to identify upcoming opportunities for economic development communications and curate content for a new e-newsletter that is planned for launch in May, as part of the business retention and expansion program.
- Staff completed a framework for workforce program development for Build C3. Areas of program development include a business incubator, apprenticeship program, and a tuition program with a partner university.
- Staff conducted a business visit with a company that provides electronic recycling services. Staff is providing business retention and expansion services.
- Staff shared a new business retention and expansion business survey with Adams County economic development staff to further business retention and expansion coordination efforts.
- Staff met with the Chamber of Commerce staff to discuss business retention and expansion services in addition to partnership opportunities for multiple economic development programs.
- Staff met with the Finance team to review and discuss opportunities to better utilize existing city datasets in economic development strategy development and implementation.
- Staff attended the Site Selectors Guild Annual Conference in Nashville, Tennessee. The annual conference provides a platform for economic development professionals to connect with site selection consultants, fostering vital relationships between economic developers and site selection consultants. Through the sharing of valuable information and feedback, this helps make regions and communities more competitive and successful.
- Staff connected with a company that is exploring annexation into Commerce City. Staff met with internal departments to provide a tentative timeline for the process.
- Staff connected with Adelante Community Development staff members to confirm their small business and entrepreneurship training services for the 2024 calendar year. Staff is partnering with Adelante by providing access to the Small Business Resource Center to host their training services.
- Staff met with Urban Renewal Authority, Public Works, and Community Development staff to review previous investments and discuss active projects in the Derby area. The group also confirmed the need to meet monthly to identify and implement strategies designed to continue to advance the vitality of the area.
- Staff completed a full business resource library that will be used to populate the Elevate Commerce/Qwally website. The data garnered for the website will also be used to update the Small Business Resource Guide book.
- Staff provided business retention and expansion services for a business in Derby. An alley maintenance issue between property owners was discussed with a referral to the public works.

# Public Safety

## Commerce City and Brighton Police Announce Important Partnership During April's Sexual Assault Awareness Month

Commerce City and Brighton Police Departments are introducing a new online tool for sexual assault survivors. Together our departments are implementing "Seek Then Speak," an online tool to help sexual assault survivors access information when they need it and start reporting when they are ready.

"By providing various options to reporting, survivors have broader access to justice and healing. Most sexual assault victims never report the crime to law enforcement, and those who do face significant barriers when engaging with the criminal justice system," said Brighton Police Chief Matt Domenico.

CCPD and BPD have had a combined Sexual Assault Task Force (SATF), as well as a shared victim services unit, for several years. Together, this team takes a victim-centered, offender-focused approach to investigating sexual assaults in both cities.

"Our hope with the implementation of this tool is that it will empower survivors with the information and resources they need in order to begin to move forward in a way they feel most comfortable with," said Commerce City Police Chief Darrel Guadnola.

Seek Then Speak is a free and was developed by End Violence Against Women International. Accessible on any device with internet connectivity, the tool is divided into two key functions:

**SEEK:** Provides sexual assault survivors and those supporting them with a way to privately gather information and explore options for medical care, supportive services, and reporting to law enforcement.

**SPEAK:** Provides survivors with a detailed, self-guided interview that can be completed at their own pace, and in as much or as little detail as they are comfortable with.

It is designed for survivors and those supporting them at any time and place. If a survivor begins reporting, a PDF document will be generated that they can download to their own device to be saved. From there, they can choose to email it to law enforcement, print it and provide it in person to the appropriate department, or give it to a sexual assault advocacy center to submit to police on their behalf.

# Infrastructure

## PW Updates

### Preservation and Safety

- The city's asphalt crack repair contractor completed three repairs in the Reunion neighborhood, bringing the total cracks repaired under the current project to 94. This completed the scope of the current contract. Another contract will be bid in April for another round of repairs.
- Bids were received for the 2024 Concrete Flatwork and Repair Program. This project will be on the April 15 City Council agenda for award.

### Engineering

- A pre-construction meeting was held for the Colorado Boulevard Paving and Multi-modal Improvement Project between E. 68th and E. 70th avenues. Construction is planned to start mid-April.
- A project kickoff meeting was conducted for the Third Creek Tributaries Floodplain Project. The project is being managed by the Mile High Flood Control District and will map the floodplain for three tributaries flowing into Third Creek on the east side of the city.
- Staff attended the North Area Transportation Alliance (NATA) meeting.
- A railroad diagnostic meeting was held at the Burlington Northern Santa Fe (BNSF) crossing for the E. 88th Avenue Widening Project to confirm the requirements for the widened crossing proposed for the project.
- A weekly meeting was conducted for the E. 120th Avenue Widening Project between Chambers and Buckley roads.

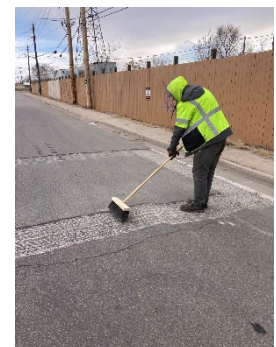
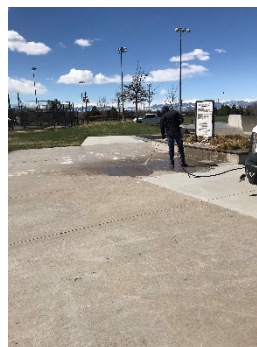
### Parks

- Staff focused on ballfield maintenance for upcoming baseball activities. Fence repairs were also completed at Pioneer Park at the Moore and Capra fields.
- Staff performed maintenance on the following soft surface trails: Prairie Gateway Open Space, Ragweed Draw, Belle Creek, and Dunes Park.
- In response to the snow storm that rolled in Sunday through early Monday morning, staff members worked on cleaning sidewalks around city buildings and walkways spending a total of 134.5 hours shoveling and removing snow.

- Staff began applying herbicide to areas throughout the trails to control noxious weeds along the Sand Creek Trail and Derby trailheads.
- Staff added six tons of recycled asphalt to the parking lot located on the south side of E. 96th Avenue at the Rocky Mountain National Refuge Perimeter Trail to level the parking area. This improvement will not only enhance the durability and longevity of the parking lot surface, but also contributes to our sustainability efforts by utilizing recycled materials.

### Streets

- The Sweeping crew completed sweeping operations on E. 56th Avenue removing debris and dirt. The Sweeping crew also cleaned up a rock spill from the southbound lanes of Tower Road at E. 104th Avenue.
- Staff cleaned the drainage catch pans on E. 60th Avenue and Parkway Drive. Regular maintenance of catch pans helps prevent debris build-up and improves drainage efficiency.
- The Traffic team installed a four-way stop at the intersection of E. 93rd Place and Landmark Drive.

## Emergency Action Plan Training Recap

On March 17 and 24, facility and aquatics staff from both the Bison Ridge and the Eagle Pointe recreation centers worked with the Police Department and Emergency Management staff on execution of the Emergency Action Plans for the facilities. These trainings included active shooter scenarios, fire extinguisher deployment and use, fire and severe weather evacuation points, meeting locations, de-escalation techniques, and medical emergency responses. These trainings help ensure staff have the knowledge and training to respond to any incident effectively and appropriately. Thank you to everyone who participated in these trainings.



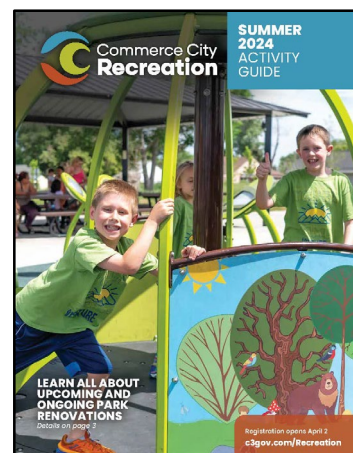
## Adams County Mayors and Commissioners Youth Awards (ACMCYA)

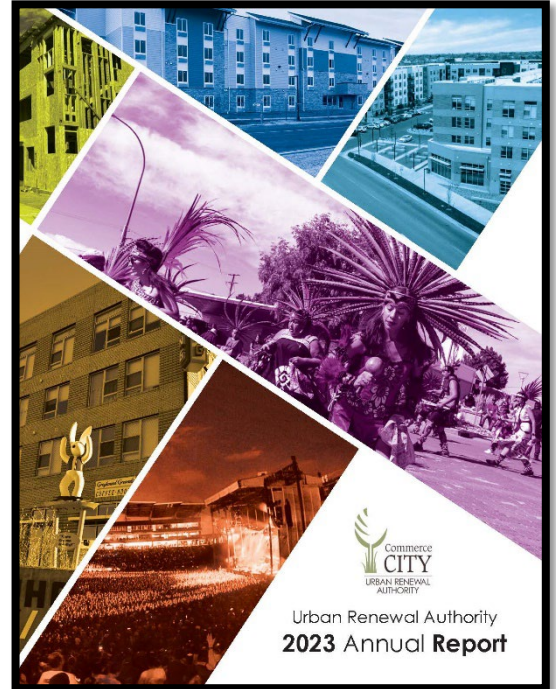
# Urban Renewal
