REQUEST

Approve a resolution extending the construction contract to Gold Star Concrete in the additional amount of \$899,930.99 for 2025 Concrete Flatwork project.

BACKGROUND

Annually, the City awards a contract for concrete flatwork in the City rights-of-way (ROW). The work to be performed under this contract includes removal and replacement of concrete pavement panels, curb, gutter, sidewalk, curb ramps, cross-pans, concrete pads, and related work at locations provided by the Commerce City Public Works Department (see project maps). In addition, this program installs sidewalks at locations where none currently exist in City ROWs.

The City advertised the request for bids for Concrete Flatwork in 2024 and Gold Star was awarded a contract for one year with an option to renew up to two additional one-year periods depending on the performance of the contractor. Because the contractor performed well in 2024, the condition to extend Gold Star's contract for an additional year has been met. The amount budgeted reflects the costs for both 2024 and 2025, reflecting the total cost of the contract with the extension.
