#### What is the CAPER?

- The City's 2021-2025 Consolidated Plan is carried out through Annual Action Plans (AAPs).
  - AAPs provide a concise summary of the actions, activities, and resources that will be used each year to address the priority needs and specific goals identified by the Consolidated Plan.
- The City reports on accomplishments and progress toward Consolidated Plan goals in the Consolidated Annual Performance and Evaluation Report (CAPER).

- A report on resources and investments
- A report on goals and outcomes
- A report on progress towards providing affordable housing
- Demographic composition of individuals and families assisted
- Citizen participation efforts

### Persons Assisted by Race/Ethnicity

- The number of persons assisted by race/ethnicity (192 persons):
- By Race:
  - White = 142 (79%)
  - Black or African American = 19 (11%)
  - American Indian or Alaska Native = 2
     (1%)
  - Other (Asian, Native Am, Native Hawaiian, etc.) = 17 (9%)

- By Ethnicity:
  - Hispanic = 109 (61%)
  - Non-Hispanic = 71 (39%)
