





Garden of the Gods

- Examining *measurable* economic benefits of parks and trails
- Translating *perceived* values into dollars
- Parks and trails can:
 - Enhance property value
 - Support tourism
 - Enable recreation
 - Increase public health
 - Provide economic development
 - Reduce stormwater and air pollution

Economic Benefit Analysis Colorado Springs



Garden of the Gods

- Property value:
 - \$502 million property value
 - \$2.58 million property taxes
- Tourism:
 - \$135 million spending
 - \$6.36 million local taxes
- Recreation: \$58.7 million
- Health: \$56.5 million
- Economic development:
 - \$32.4 million spending
 - 88 stores, \$178 million sales, 986 employees
- Stormwater: \$3.01 million
- Air pollution: \$201,000



Engagement Ideas

Ways to advocate and engage with your State and Federal Elected Officials Everyone Loves An Event

- Invite them to your Special Events, Concert, Ribbon Cutting, Groundbreaking, and Fundraisers
- Recognize them publicly for being there, include them as a VIP, and have them hoist a shovel, cut the ribbon. Plenty of opportunities for photo ops.
- Provide them speaking points and give them a part in the program.
- Have them host a table at your fundraiser or be sure your table captains reach out to all of them to get them to your event.



Ways to advocate and engage with your State and Federal Elected Officials Make the Connection

- Many leaders started in Parks and Recreation
- Get to know their stories and make that connection
- Engage through their experiences and background



Ways to advocate and engage with your State and Federal Elected Officials

Use the 100 cups of coffee or tea

- Creates opportunities for Networking, Collaborating, Sharing, Brainstorming, and Learning.
- Participate or create a meet and greet for all elected leaders
- Send Thank you notes with a photo to their offices for projects that were funded by an agency at their leadership level.
