## REQUEST

Request City Council formally approve and initiate a collaborative meeting between Brighton City Council and us alongside with their respective departments. The objective of this meeting is to discuss and identify opportunities for collaboration on matters of shared interest between the two cities and to facilitate a dialogue that explores potential collaborative efforts beneficial to both communities.

Commerce City Council is requested to compile and submit to the City Manager a list of interests and topics from each councilmember, intended for discussion. Brighton City Council is similarly requested to prepare and share their interests for a comprehensive dialogue. The idea may spark shared concerns and challenges both city councils may have that we may be able to work through together with staff.

The outcome of this meeting aims to strengthen ties between the two councils and lay the groundwork for joint initiatives that can lead to shared benefits.

My motion is to direct the City Manager to 1) determine if Brighton City Council would be interested in this joint collaboration 2) determine timing of when both city councilmembers may be available for this one of many positive interactions, and 3) ensure both city councilmembers would provide a list of shared interests that may lead to fruitful and
