



Why I would be a good council member for Commerce City if appointed:

I moved to Commerce City when I was 8 years old. Having lived in Commerce City for over 15 years I have seen council member after council member come in and out and fail us, the residents. I have seen council members who are disconnected from what their constituents say and want. I grew up in this city and I have seen others fail in trying to build a Quality Community for a Lifetime at our expense. If appointed to fill the vacancy on City Council I would bring a unique background which includes small business, finance, operations, and management. I have a finance degree from the University of Colorado-Denver. I owned a bookkeeping business while in college. I have various experience in IT and operational positions within three Fortune 200 companies. I am currently a Corporate Accountant at Dish Network. I also served on two separate Boards and Commissions in Commerce City and interacted with the city (and City Council) in various ways. The biggest area of opportunity I see in the city relates to economic/business development. I would like to use my previous experiences and knowledge to better and strengthen the development of our city. Throughout my various life experiences, I have been equipped with skills that will help our city achieve its goals and fulfill our goal of building a Quality Community for a Lifetime.

1. Why are you applying to be on the City Council?

I am applying to be on the City Council to build a quality community for residents and cultivate a community with robust communities and business developments. I am applying for council because I feel that many council members in the past have not been as interested in the city as they should or could have been, which led to many short-term and long-term issues for our city. 4. What do you believe to be the three most pressing challenges or concerns in the Commerce

City community?

The most pressing issue I see in the city is the lack of retail and food/restaurant development. I would like to see the city be even more aggressive in the promotion and acquisition of large retailers and food/restaurant establishments. Another concern I have is the Suncor Refinery. I am concerned about its effects on our environment (within the city). The city should attempt (if possible) to exhaust all options regarding its' due diligence in utilizing every tool it has to keep the RMANWR and the Suncor Refinery transparent and accountable. The refuge is managed by the Federal Government which severely limits the city's ability to intervene in RMANWR affairs. Suncor is a major employer (one of the largest employers in the city) and making sure Suncor is transparent and accountable for how it interacts with the environment (within the city) is vital. Ensuring the Suncor relationship endures is a huge benefit to ensuring a Quality Community of Lifetime for our residents. One other issue I believe is pressing is homelessness issue. As cities around the country continue to deal with this epidemic, Commerce City must ensure that it is proactively working with all relevant stakeholders to ensure that the city is meeting its obligations in ensuring a Quality Community for a Lifetime.

5. What do you see as the three biggest opportunities for Commerce City right now?

The biggest opportunity I see in the city is retail and food/restaurant development. The second biggest opportunity I see in our city is education creating new opportunities for our residents to learn and grow outside of the traditional two-four year degree programs. Another opportunity I see is the completion (and continuation) of residential development within the city whether that development is in Derby or the North Range.
