Update: Oasis Park and Second Creek Park Design

The Parks, Recreation, and Golf Department and Galloway & Company held the second public outreach meeting on Tuesday, March 7 at Bison Ridge Recreation Center. The public and stakeholders were invited to participate in the design process by attending the meeting or submitting comments via email to tferguson@c3gov.com. Approximately 25 residents attended the public meeting and staff received four comments via email prior to the meeting.

Residents commented that they appreciated being heard and liked the preliminary conceptual plans (basic programming for both parks). Residents provided feedback that will be taken into consideration with the next phase of design development, such as options for amenities within each program area identified in the park concept. Staff expects to hold another public outreach meeting sometime in April. Date, time and location information will be shared when it has been determined.

Executive Summary

This update is intended to provide a weekly update of environmental policy and planning work including, but not limited to:

- Environmental Policy Advisory Committee (EPAC), Lotus Contract and Community Outreach
- Municipal Sustainability
- Updates on information regarding the Suncor Refinery and its operations
- Legislative Updates & Regional Environmental Leadership
- Colorado Oil and Gas Conservation Commission (COGCC) Regulations & Applications

Environmental Policy Advisory Committee (EPAC) and Community Outreach

EPAC members and staff will be participating in two events in March regarding air quality. On March 15 10AM – 12, there will be a Forum at University of Denver 2022 E Evans Street to discuss the Air Quality Investigation and Research for Equity (AIRE) Program which centers on the Suncor Refinery.

Lotus Engineering & Sustainability Contract Progress

Lotus met with staff to discuss progress on the municipal inventory baseline project. Data gaps exist for commuter travel; fleet utilization; trash, composting and recycling and energy intensity in buildings per sq. footage. Staff commuter data may need to be extrapolated by zip code and modeling data because of low commuter survey response rates.

As part of the strategies task, Lotus is beginning to develop monthly challenges to help educate staff and community members about sustainable actions to reduce air emissions and improve community health. The task aligns with the recommendation by EPAC and the internal Sustainability Initiative Committee that increased education is necessary to build capacity and knowledge.



Municipal Sustainability

CD and PW staff worked together to calculate electricity use at select facilities that could be included in the Long Duration Storage grant proposal. Sites selected included the Civic Center; Municipal Service Center; Bison Ridge Recreation Center; Eagle Point Recreation Center and a leased daycare facility. The grant didn't include Parks or ODLP but the annual costs are \$1,231,748 and \$63,053 so those facilities may be addresses in a future submittal.

Suncor Refinery

The refinery had three water exceedances and seven air exceedances. The updated data has been uploaded to the city website. The initial water investigation of the benzene discharge incident indicates that the elevated benzene concentrations are related to Suncor's wastewater treatment system biological reactors, where most of the treatment for benzene occurs. Because the refinery's process units were offline during the month of January, the characteristics of the wastewater going into the biological reactors changed, resulting in a reduction in biological activity and a corresponding drop in treatment efficiency. This issue was exacerbated by below average air temperatures in the area during the month.



Legislative Updates & Regional and State Environmental Protection Leadership

The two major issues that were addressed this week are comments to the Regional Air Quality Control (RAQC) Board about ozone and the statutory limits of the proposed GEMMs 2 rule-making. The following recommendations were submitted to the RAQC:

Transportation:

- Commitment to adopt Advanced Clean Cars II (ACC II) as soon as possible: Colorado has already adopted ACC I through the adoption of the low emission vehicles standards (LEV) and zero emission vehicle standards (ZEV) but will need to separately adopt ACC II once the California Air Resources Board (CARB) adopts it. This will likely happen next year after which time all the states that have previously adopted California's rule will need to update their own regulations to follow suit with the more protective standards.
- Programs that increase transit ridership and bike and pedestrian infrastructure help reduce VMT: Under the Clean Air Act, Severe ozone nonattainment areas are required to include vehicle miles traveled (or VMT) growth offsets in the SIP. Relying solely on cleaner vehicles does nothing to reduce VMT. Even though ETRP failed in 2021, the SIPs need to include some type of control measure that will decrease VMT. SB22-180 is a start, with free bus fare during August of 2022 and 2023 and increased funding to CDOT for their transit program, but a lot more is needed. South Coast Air Quality Management District is one example of an area with a VMT reduction rule.
 - Indirect source rules (ISR): The RAQC should move ahead with the inclusion of ISR for at least one sector, such as the warehouse sector. Transportation is a major contributor to ozone and we need to do more to reduce emissions from this sector but land use is also key to the success of this strategy but is under the purview of local governments.

Industrial Sources:

• Flaring controls or flare minimization plan at the Suncor refinery: refinery flaring should be limited; one possibility is a flare minimization plan rule which has been used at several refineries in California.

Area Sources:

- Adopt California's non-road engine standards: California has regulations for heavy-duty off-road compression-ignition engines and large off-road spark-ignition engines 25 hp or greater. The RAQC has been researching this and should move ahead with this plan; under the Clean Air Act, other states can adopt California's engine emissions regulations.
 - Small off-road engine emissions standards: Lawn and garden equipment contributes significantly to VOC
 emissions. Emissions standards for this category should be included in the SIPs to reduce emissions while
 Colorado waits for a shift in the market to all electric equipment. California's small off-road engine (SORE)
 program is one example of an existing program.

Low NOX appliance requirements for residential and commercial buildings: Several other states have rules
that could be used as examples. Utah has a rule for water heaters and South Coast AQMD has rules that
target residential and commercial space and water heating and cooking.

Oil & Gas Updates

As part of the RAQC submittal described above, the following recommendations were submitted related to Oil and Gas operations:

- Curtail high emitting oil and gas activities during ozone season: This could be done through a time-out for oil and gas drilling and/or completions during ozone season. Reductions could also be achieved through curtailing specific ancillary activities such as minimizing vehicle and engine idling, reducing truck and employee traffic, delaying vehicle refueling, suspending or delaying use of gas-powered ancillary equipment, and postponing construction and maintenance activities. Other possibilities are restricting well unloading and non-automated condensate tank load out activities on ozone action days unless there is a safety issue or damage to equipment.
- Flare minimization plans for oil and gas operations: Oil and gas operations should submit plans that will minimize their use of flaring.

No additional information has been submitted by either applicant. Submittals with no status changes are listed in Appendix A.
