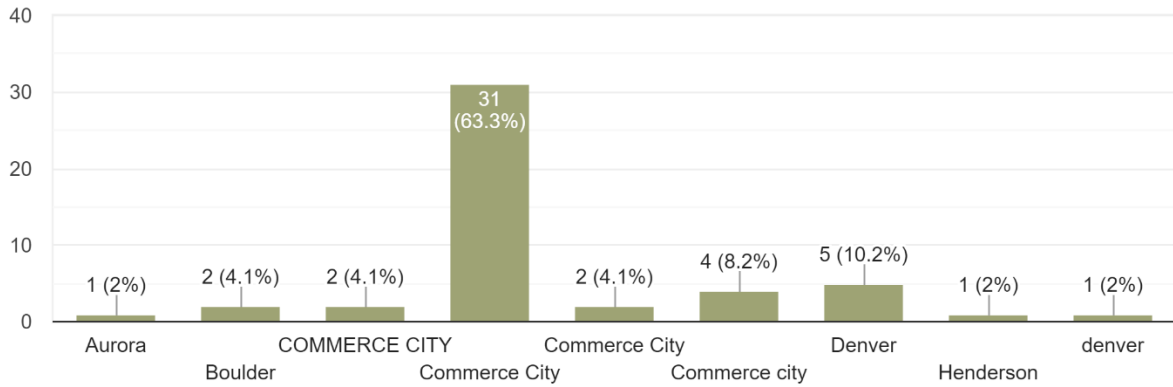
Are you a resident of Commerce City?

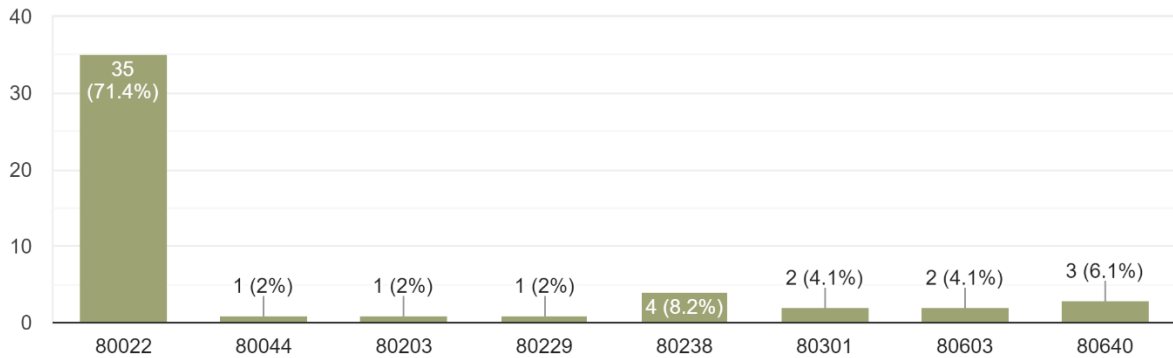

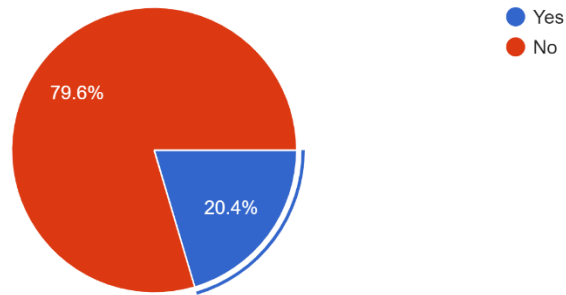

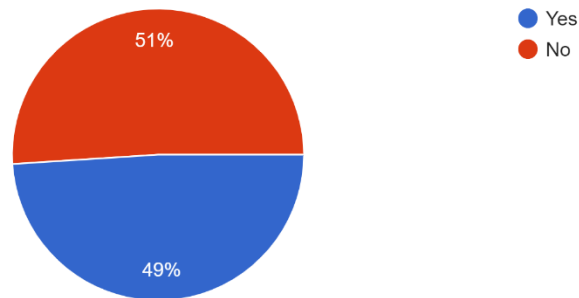
Are you affiliated with a 501(c)(3) nonprofit?

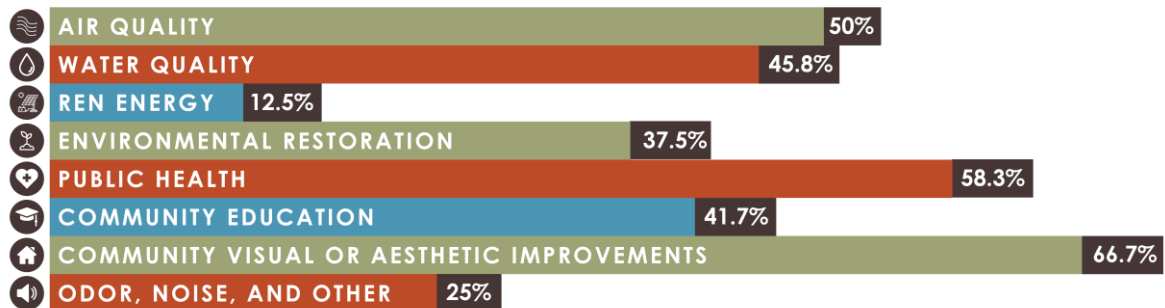


Do you have a specific idea for a SEP project submission you would like Commerce City staff to consider?

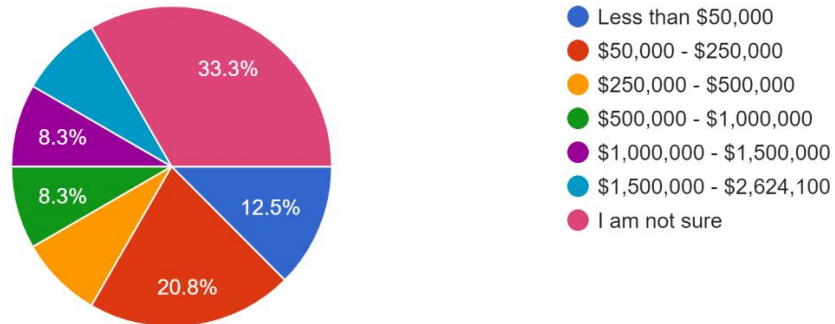
Which of the areas listed below do you believe your proposed project would improve, if implemented?

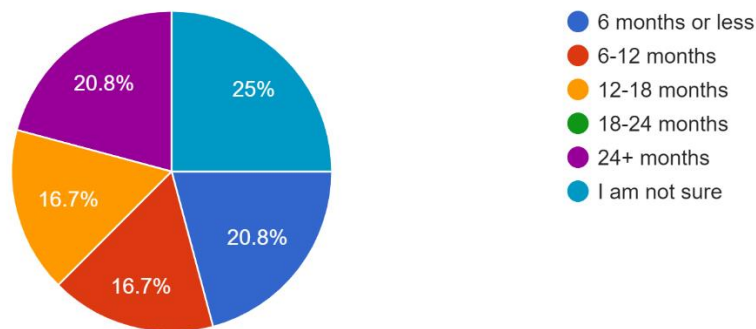
Estimated Project Budget (\$USD)

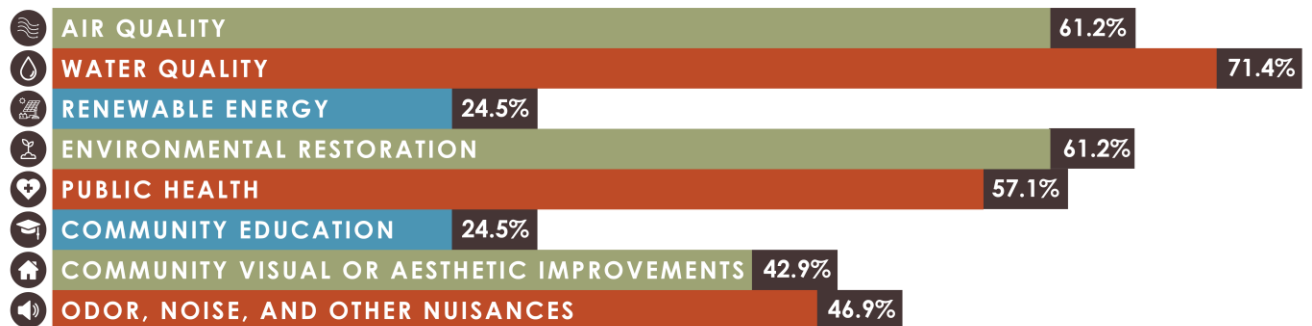


How long do you think it would take to successfully implement your project?
