Executive Summary

This update is intended to provide a weekly update of environmental policy and planning work including, but not limited to:

- Environmental Policy Advisory Committee (EPAC), Lotus Contract and Community Outreach
- Municipal Sustainability
- Updates on information regarding the Suncor Refinery and its operations
- Legislative Updates & Regional Environmental Leadership
- Colorado Oil and Gas Conservation Commission (COGCC) Regulations & Applications

Environmental Policy Advisory Committee (EPAC) and Community Outreach

Lotus has submitted an SOQ for grant and EPAC support. Dr. Russo presented to the Youth Commission and discussed the possibility of a Youth Sustainability Team. CD staff coordinated with Parks and RMA on various Earth Day events, provided native sunflower seed packets and promoted the April Sustainability Challenge: Seeds of Change at Eagle Pointe and Bison Ridge Recreation Centers.

Staff submitted an article for Community Connects about the Green Networking opportunities to access free LED lighting and audits for commercial businesses.

Lotus Engineering & Sustainability Contract Progress

Lotus submitted the Low Impact Development Guidance document after consultation with Community Development and Public Works staff. The LID intends to reduce water pollution in Commerce City from point and nonpoint sources. The LID Guidance Document includes an easily implementable checklist for permit applicants and city staff. The document has been cross-referenced with the existing Storm Water Plan. Staff will work with the Land Development Code contractors to incorporate necessary amendments. Refer to Attachment A for details.

Lotus will submit a Spanish version of the Sustainability Action Plan in April. Both versions of the Action Plan will be posted on the city's website, and Cultivando will share them with community members. Lotus has nearly completed the Municipal GHG Inventory except for the fuel and fleet data. The estimate of completion is four weeks.

Municipal Sustainability

Staff continues to gather data for the Municipal GHG Inventory database and a solar database of local solar providers, trainers, and non-profits in anticipation of potential grant opportunities and as a resource for community members and businesses. The staff has received public technical, financial, and legal inquiries about solar resources.

Dr. Russo has provided an environmental review of several CD permits and developed general best practices for abandoned landfill sites. Rosemarie is working with NREL regarding procurement and technical recommendations for solar shade structures at the Civic Center.

Suncor Refinery

Suncor has begun scheduled maintenance of Plant 2. The maintenance program will be conducted from April to June, involving an additional 700 people daily. Suncor personnel expect increased traffic @ shift changes (4-8 a.m. & 4-8 p.m.). The reliability improvements are expected to reduce air emissions and cost approximately \$100 million.

Legislative Updates & Regional and State Environmental Protection Leadership

Staff worked with Denver and several state agencies on the EJ GTG Home Electrification proposal submitted on April 14. This program will address air quality and pollution, mitigating indoor air quality, whole-home electrification, and weatherization retrofits. If funded, the program will provide home electrification and weatherization retrofits for 12 households with critical needs in Denver's Globeville, Elyria Swansea, and Northeast Park Hill neighborhoods and the City of Commerce City. Energy Outreach Colorado (EOC) will help meet the goals of reducing greenhouse gas emissions from income-qualified homes, improving indoor air quality, and reducing exposure to pollutants for those living with chronic respiratory and health conditions. These retrofits will be paired with targeted community engagement focused on air quality and health and will engage key stakeholders at the local, state, and utility levels. The project will be targeted to address low-income populations with chronic respiratory conditions in Denver's Globeville (Census tract: 08031001500), Elyria Swansea (08031003500), and Northeast Park Hill (08031004101, 08031004102) neighborhoods and Commerce City (08001008709, 08001008901). It qualifies for the Climate Change/Disaster Resiliency special consideration

due to the household cooling added and targeted vulnerable populations living with chronic respiratory issues, susceptible to extreme heat and poor air quality events. In Colorado, wildfire season coincides with the hottest part of the year. By providing weatherization and electrification upgrades, participants will have access to filtered, conditioned indoor air at all times, which is critical to life safety for these populations. Energy Outreach Colorado (CBO), City of Commerce City (Local Government), Tepeyac Community Health Center (CBO), Groundwork Denver (CBO), Mile High Youth Corps (CBO), Colorado Indoor Environment Program (State Program), the Hazardous Materials and Waste Management Division's Radon Program (State Program) will be partners.

Rosemarie Russo has been tracking and participating in bi-weekly meetings with other local government coalitions regarding five environmental protection rule-makings. The legislation addresses Oil & Natural Gas Methane Intensity; EJ Definition of DI Communities; Mineral Pooling; COGCC Mission Change, and GEMMs 2. Rosemarie will be testifying and/or submitting comments to CDPHE and COGCC regarding the potential impacts of the proposed legislation.

Oil & Gas Updates

Staff attended the Energy and Environment Symposium in Rifle, Colorado. The main topics addressed included the COGCC mission change, environmental justice considerations, and cumulative oil and gas development health impacts. CDPHE (state), under an MOU with EPA (federal), is reviewing existing industrial permits and new Oil & Gas permits in DI communities. The state has a new EJ Ombudsman for air and water complaints from drilling operations. The contact information will be added to the City's webpage. Additionally, several panels addressed the proposed Oil & Natural Gas Methane Intensity verification methods and reporting requirements.

There were no new 2A Forms submitted to the state for Commerce City.

2	High Urgency and Mid-High Impact	Prioritized to be accomplished on the scheduled agenda. Think grant or contract deadlines that are important to acomplish and have a mid-high impact on the community or funding for a project.
3	Mid-High Urgency and Mid-High Impact	Item can be moved to another date within 2-3 months if necessary. Think of getting Council or community feedback for planning a project or hosting an event for the community in the near future.
4	Low-Mid Urgency and Low-Mid Impact	Item can be scheduled within 3-6 months. Think of planning for an upcoming years goals, projects, or events that need advance Council notice and feedback, execution of a contract, document, or grant application in the near future.
